AN ACT to amend the social services law, in relation to reimbursement for special transportation services

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 368-d of the social services law is amended by 1 adding a new subdivision 7 to read as follows:

- 7. The commissioner shall, beginning upon the effective date of this 3 4 <u>subdivision and on an ongoing basis thereafter, review whether current</u> state rules, regulations, policy, billing guidelines and amendments 5 6 under the state plan for medical assistance concerning medicaid 7 reimbursement for special transportation services, which are furnished by school districts to children with handicapping conditions receiving medical care and services that qualify for reimbursement under this 9 10 title, are more restrictive than required by federal law, regulations, 11 or policy. The commissioner shall take all practicable steps to ensure 12 that any necessary changes are made to state rules, regulations, policy, 13 and billing quidelines, and submit any necessary proposed state plan amendments to the centers for medicare and medicaid services, to ensure 14 receipt of all available federal financial participation under title 15 16 <u>nineteen of the federal social security act for transportation services</u> 17 furnished by school districts to children with handicapping conditions. In so doing, the commissioner shall: 18
- (a) seek to ensure receipt of all available federal financial participation for transportation services furnished to children with both 20 21 physical and non-physical disabilities;

- (b) seek to ensure receipt of all available federal financial partic-22 23 ipation for transportation services involving accommodations including, 24 but not limited to, safety restraints and harnesses, medical equipment, paraprofessional or nursing services, smaller vehicle size, alternative 25 26 vehicle routing, and climate control;
- 27 (c) consider whether other states have less restrictive rules, requ-28 lations, policy, billing guidelines and approved state plan amendments

- § 2. Section 368-e of the social services law is amended by adding a new subdivision 6 to read as follows:
- 6. The commissioner shall, beginning upon the effective date of this 8 9 subdivision and on an ongoing basis thereafter, review whether current 10 state rules, regulations, policy, billing guidelines and amendments 11 under the state plan for medical assistance concerning medicaid reimbursement for special transportation services, which are furnished 12 13 by counties and the city of New York to preschool children with handi-14 capping conditions receiving medical care and services that qualify for reimbursement under this title, are more restrictive than required by 15 16 federal law, regulations, or policy. The commissioner shall take all practicable steps to ensure that any necessary changes are made to state 17 rules, regulations, policy, and billing guidelines, and submit any 18 19 necessary proposed state plan amendments to the centers for medicare and 20 medicaid services, to ensure receipt of all available federal financial 21 participation under title nineteen of the federal social security act for transportation services furnished by counties and the city of New 22 York to preschool children with handicapping conditions. In so doing, 23 24 the commissioner shall:
 - (a) seek to ensure receipt of all available federal financial participation for transportation services furnished to preschool children with non-physical disabilities;
- 28 (b) seek to ensure receipt of all available federal financial partic29 ipation for transportation services involving accommodations including,
 30 but not limited to, safety restraints and harnesses, medical equipment,
 31 paraprofessional or nursing services, smaller vehicle size, alternative
 32 vehicle routing, and climate control;
- 33 (c) consider whether other states have less restrictive rules, requ-34 lations, policy, billing guidelines and approved state plan amendments 35 concerning medicaid reimbursement for special transportation services 36 furnished by school districts to preschool children with handicapping 37 conditions; and
- 38 (d) consult with representatives of counties and the city of New York.
- 39 § 3. This act shall take effect immediately.
