AN ACT to amend the environmental conservation law, in relation to authorizing hunting big game by rifle in the county of Tompkins; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the 2 environmental conservation law is amended by adding a new item (o) to 3 read as follows:

§ 4. Item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as separately amended by chapters 125, 133, 204, and 243 of the laws of 2017, is amended to read as follows:

- 10 (f) Southern tier, Deer and bear, first Pistol, shotgun, 11 central and Western Monday after November crossbow, muzzle 12 region, except those 15 through first loading firearm 13 counties or portions Tuesday after or long bow only 14 thereof listed in December 7 15 item(i),(j),(j),16 (k) [ex], (1) or (m)
- 18 § 5. This act shall take effect immediately, provided that:
- 19 a. the amendments to paragraph a of subdivision 2 of section 11-0907 20 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended; 22
- b. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section 24 two of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;
- 28 c. sections three and four of this act shall take effect upon the 29 expiration and reversion of paragraph a of subdivision 2 of section 30 11-0907 of the environmental conservation law, as provided in section 13 of chapter 600 of the laws of 1993, as amended; and 31
- 32 d. nothing contained in this act shall be construed so as to extend 33 the provisions of this act beyond October 1, 2022, when upon such date this act shall expire and the provisions contained herein shall be 35 deemed repealed.
