AN ACT to amend the election law, in relation to including a statement on the envelopes of ballots for absentee voters and special presidential voters for signature affirmation

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 6 of section 7-122 of the election law, as amended by chapter 411 of the laws of 2019, is amended to read as follows:

6. On the reverse side of such inner affirmation envelope shall be printed the following statement:

AFFIRMATION

I do declare that I am a citizen of the United States, that I am duly registered in the election district shown on the reverse side of this envelope and I am qualified to vote in such district; that I will be unable to appear personally on the day of the election for which this ballot is voted at the polling place of the election district in which I am a qualified voter because of the reason given on my application heretofore submitted; that I have not qualified nor do I intend to vote elsewhere, that I have not committed any act nor am I under any impediment which denies me the right to vote.

I hereby declare that the foregoing is a true statement to the best of my knowledge and belief, and I understand that if I make any material false statement in the foregoing statement of absentee voter, I shall be guilty of a misdemeanor.

10 I do declare I am a qualified special presidential voter of said
11 district; that I am not qualified and am not able to qualify to vote
12 elsewhere than as set forth on the reverse side of this envelope; that I
13 am a citizen of the United States; that on the date of the election for
14 which this ballot is voted, I will be at least eighteen years of age;
15 and that I have not committed any act, nor am I under any impediment,
16 which denies me the right to vote.

17 I hereby declare that the foregoing is a true statement to the best of
18 my knowledge and belief, and I understand that if I make any material
19 false statement in the foregoing statement, I shall be guilty of a
20 misdemeanor.
