AN ACT to amend the vehicle and traffic law, in relation to authorizing a residential parking system in certain parts of the hamlet of Oceanside in the Town of Hempstead

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Subdivision 2 of section 1662-e of the vehicle and traffic 2 law, as added by chapter 267 of the laws of 2013, is amended to read as 3 follows:
- 2. Such residential parking permit system may only be established
- 5 <u>(i)</u> within the area known as East Meadow of the town consisting of the following roadways:
 - (a) Roosevelt Avenue west of Prospect Avenue;
 - (b) Jefferson Street west of Prospect Avenue;
 - (c) First Street west of Prospect Avenue;
- 10 (d) Second Street West of Prospect Avenue;
- 11 (e) Third Street west of Prospect Avenue;
- 12 (f) Fourth Street west of Prospect Avenue;
- 13 (g) Clearmeadow Drive;
 - (h) Nottingham Road;
- 15 (i) Florence Court;
- 16 (j) Jane Court;

- 17 (k) Dofena Lane;
- 18 (1) Franklin Avenue north of 4th Street;
- 19 (m) Bailey Avenue;
- 20 (n) Franklin Avenue, north of 7th Street and south of Hempstead Turn-21 pike;
- 22 (o) Lincoln Avenue, north of 7th Street and south of Roosevelt Avenue;
- 23 (p) 5th Street, west of Prospect Avenue;

- 28 § 2. This act shall take effect immediately.
