AN ACT to amend the navigation law, in relation to rates for pilotage on the Hudson river

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph 1 of paragraph (b) of subdivision 4 of section 89-a of the navigation law is amended by adding two new clauses (vi) and (vii) to read as follows: 3

4 (vi) Effective January first, two thousand twenty-one, the following 5 <u>base pilotage rates shall be applicable:</u>

All vessels of 100 pilotage units and over shall pay \$13.34 per pilo-7 tage unit for Section 1, Lower River; Yonkers, to all ports through Hyde 8 Park.

The following base pilotage rates shall be applicable to Section 1, 9

10 Lower River:

13 A maximum charge of up to 500 pilotage units shall be applicable.

All vessels of 100 pilotage units and over shall pay a base pilotage 14
