AN ACT to amend the alcoholic beverage control law, in relation to authorizing retail licensees for on-premises consumption to sell and/or deliver alcoholic beverages for consumption off the premises

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 106 of the alcoholic beverage 1 control law, as amended by chapter 297 of the laws of 2016, is amended 2 3 and a new subdivision 3-a is added to read as follows:

3. [No] Except as provided in subdivision three-a of this section, no 4 5 retail licensee for on-premises consumption shall sell, deliver or give б away, or cause or permit or procure to be sold, delivered or given away 7 any liquors and/or wines for consumption off the premises where sold. The provisions of this subdivision shall not prohibit a licensed winery 8 9 or farm winery from allowing a patron to leave the winery or farm winery 10 with a partially consumed bottle of wine provided that the removal of 11 the bottle is done in accordance with subdivision four of section eight-12 y-one of this chapter.

13 3-a. (a) Notwithstanding any other provision of law to the contrary, a 14 retail licensee for on-premises consumption, upon approval by the 15 authority, may sell and/or deliver certain alcoholic beverages for 16 consumption off the premises where sold. Such licensee may only sell 17 and/or deliver for consumption off the premises alcoholic beverages for 18 which such licensee is licensed to sell for consumption on the premises. (b) A retail licensee for on-premises consumption shall only permit 19 20 the sale or delivery of alcoholic beverages: 21 (i) with the purchase of food;

(ii) in any closed or sealed container not to exceed sixteen fluid 23 ounces per container for beer or cider, five fluid ounces per container for wine, and ten fluid ounces per container for liquor mixed with non-24 25 alcoholic beverages, provided such sale or delivery is consistent with 26 municipal open container ordinances; and

27 (iii) during licensed hours of operation.
