AN ACT to amend the mental hygiene law, in relation to establishing the frontline workers trauma informed care advisory council

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The mental hygiene law is amended by adding a new section 7.48 to read as follows:

§ 7.48 Frontline workers trauma informed care advisory council.

3 (a) The commissioner shall establish the frontline workers trauma 4 informed care advisory council within the office. The council shall 5 6 consist of, at a minimum, the commissioner or his or her designee; the 7 commissioner of the department of health or his or her designee; the commissioner of aging or his or her designee; the commissioner of the office for people with developmental disabilities or his or her desig-9 10 nee; the commissioner of the office for addiction services and supports 11 or his or her designee; the commissioner of the department of 12 corrections and community supervision; and twenty-one additional members 13 of which seven shall be appointed by the governor, six shall be appointed by the speaker of the assembly, six shall appointed by the 14 temporary president of the senate, and one each shall be appointed by 15 16 the minority leader of the assembly and the senate. Each appointed 17 member shall be a representative of one of the following: (1) behavioral health advocacy organizations; (2) health care provider organiza-18 tions; (3) employee organizations representing nurses, doctors, and 19 other frontline workers; (4) human services organizations; (5) law 20 21 enforcement agencies; (6) individuals who have expertise in fields of 22 discipline related to trauma informed care; and any other group, associ-23 ation, organization, or individual deemed appropriate by the commission-24 er. For purposes of this section, frontline workers shall include, but shall not be limited to, healthcare workers, first responders, direct 25 care workers, public safety workers, transportation workers, food 2.7 service workers and others who have been exposed to trauma associated

- (b) Council members shall receive no compensation for their services as members of the council, but shall be reimbursed for actual and necessary expenses incurred in the performance of their duties. The members of the council shall choose one member of the council to be a chairperson and one member to be co-chairperson.
- 8 (c) The council shall be established within thirty days of the effec-9 tive date of this section.

- 11 (1) Identify evidence-based tools to track the impact of COVID-19 associated collective trauma and the needs of frontline workers; 12
- 13 (2) Identify or develop training opportunities for organizations that 14 employ frontline workers on how to support the mental health and wellness of their impacted employees; 15
- 16 (3) Identify evidenced-based trauma-informed support resources and 17 <u>learning opportunities for frontline workers;</u>
- (4) Identify or develop a mechanism to inform and refer impacted 18 frontline workers experiencing symptoms associated with COVID-19 to 19 20 behavioral health services and supports;
- (5) Consult with any organization, government entity, agency, or person that the council determines may be able to provide information 22 and expertise on the development and implementation of trauma informed care for frontline workers; and
- (6) Submit a report to the governor, the speaker of the assembly, and the temporary president of the senate by December first, two thousand 27 twenty on the duties described in this section, including recommendations to effectively implement any initiative identified or developed by 28 the workgroup and included in its report.
- 30 (e) To the extent federal funds are available, grants shall be made available to entities that employ frontline workers or other organiza-31 32 tions with relevant experience, for the sole purpose of providing 33 support and implementing strategies or initiatives identified by the frontline workers trauma informed care workgroup for their workforce. 34
  - § 2. This act shall take effect immediately.
