AN ACT to amend the limited liability company law and the partnership law, in relation to the definition of office and the content of notices published in newspapers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision (s) of section 102 of the limited liability 2 company law is amended to read as follows:

- (s) "Office of the limited liability company" means the office of the 3 limited liability company, the location of which is stated in the articles of organization of a domestic limited liability company, or in the application for authority of a foreign limited liability company. Such 7 office [need not be a place where business activities are conducted by such limited liability company | shall be a place in the county within 9 this state of the principal and actual business location of the company. 10 In no event shall it only be the address of its registered agent, a post 11 office mailbox, or a private mailbox at a mail logistics center for 12 purposes of satisfying the requirements of section two hundred six, eight hundred two, one thousand two hundred three or one thousand three 13 14 hundred six of this chapter.
