AN ACT to amend the public service law, in relation to requiring the emergency response plan of an electric corporation to include plans for how the communication and coordination of efforts shall occur

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (a) of subdivision 21 of section 66 of the public service law, as added by section 4 of part X of chapter 57 of the laws of 2013, is amended to read as follows:

3 (a) Each electric corporation subject to section twenty-five-a of this chapter shall annually, on or before December fifteenth, submit to the commission an emergency response plan for review and approval. The emer-7 gency response plan shall be designed for the reasonably prompt restoration of service in the case of an emergency event, defined for purposes 9 of this subdivision as an event where widespread outages have occurred in the service territory of the company due to storms or other causes 10 11 beyond the control of the company. The emergency response plan shall 12 include, but need not be limited to, the following: (i) the identifica-13 tion of management staff responsible for company operations during an 14 emergency; (ii) a communications system with customers during an emer-15 gency that extends beyond normal business hours and business conditions; 16 (iii) identification of and outreach plans to customers who had docu-17 mented their need for essential electricity for medical needs; (iv) identification of and outreach plans to customers who had documented 18 their need for essential electricity to provide critical telecommuni-19 20 cations, critical transportation, critical fuel distribution services or 21 other large-load customers identified by the commission; (v) designation 22 of company staff to communicate with local officials and appropriate 23 regulatory agencies; (vi) provisions regarding how the company will 24 assure the safety of its employees and contractors; (vii) procedures for 25 deploying company and mutual aid crews to work assignment areas; (viii) 26 identification of additional supplies and equipment needed during an

1 emergency; (ix) the means of obtaining additional supplies and equipment; (x) procedures to practice the emergency response plan; (xi) appropriate safety precautions regarding electrical hazards, including plans to promptly secure downed wires within thirty-six hours of notification of the location of such downed wires from a municipal emergency official; (xii) plans setting forth how the communication and coordi-7 nation of efforts between the electric corporation, electric corporation employees, electric corporation company crews, mutual aid crews, other 9 utilities including cable television companies, internet service providers, local governments and any other entity performing services to 10 11 <u>assist such electric corporation shall occur;</u> and [(xii)] (xiii) such other additional information as the commission may require. Each such 12 corporation shall, on an annual basis, undertake drills implementing 13 14 procedures to practice its emergency management plan. The commission may 15 adopt additional requirements consistent with ensuring the reasonably 16 prompt restoration of service in the case of an emergency event. 17

§ 2. This act shall take effect immediately.
