Introduced by M. of A. WOERNER -- read once and referred to the Committee on Election Law

AN ACT to amend the election law, in relation to authorizing any qualified voter to apply for and utilize an absentee ballot

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 1, the opening paragraph of subdivision 2 and paragraphs (c) and (d) of subdivision 3 of section 8-400 of the election law, subdivision 1 and paragraphs (c) and (d) of subdivision 3 as amended by chapter 63 of the laws of 2010, paragraph (c) of subdivision 1 and subparagraph (iii) of paragraph (c) of subdivision 3 as amended by chapter 375 of the laws of 2015, and the opening paragraph of subdivision 2 as amended by chapter 216 of the laws of 1988, are amended to read as follows:

1. A qualified voter may vote as an absentee voter under this chapter if, on the occurrence of any village election conducted by the board of elections, primary election, special election, general election or New York city community school board district or city of Buffalo school district election, he or she expects to be⁺

~~(a) absent from the county of his or her residence, or, if a resident of the city of New York absent from said city, or~~

~~(b) unable to appear personally at the polling place of the election district in which he or she is a qualified voter because of illness or physical disability or duties related to the primary care of one or more individuals who are ill or physically disabled, or because he or she will be or is a patient in a hospital, or~~

~~(c) a resident or patient of a veterans health administration hospital, or~~

~~(d) absent from his or her voting residence because he or she is detained in jail awaiting action by a grand jury or awaiting trial, or confined in jail or prison after a conviction for an offense other than~~

28 absentee ballot for either a primary election or the general election in
29 any year and for those persons who will be continuously absent from
30 their county of residence during the period between the fall primary
31 election and the general election in any year to apply for ballots for
32 both such elections in such year. A voter who applies for an absentee
33 ballot shall be sent an absentee ballot for any special election or
34 winter primary that occurs during the period of absence specified in the
35 application.
