AN ACT to amend the civil rights law, in relation to reporting a nonemergency incident involving a member of a protected class

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 2 of section 79-n of the civil rights law, as added by chapter 227 of the laws of 2010, is amended to read as follows: 3 2. Any person who intentionally selects a person or property for harm 4 or causes damage to the property of another or causes physical injury or death to another or summons a police officer or peace officer without reason to suspect a violation of the penal law, any other criminal conduct, or an imminent threat to a person or property, in whole or in 7 8 substantial part because of a belief or perception regarding the race, 9 color, national origin, ancestry, gender, religion, religious practice, 10 age, disability or sexual orientation of a person, regardless of whether the belief or perception is correct, shall be liable, in a civil action 11 or proceeding maintained by such individual or group of individuals, for 12 injunctive relief, damages, or any other appropriate relief in law or 13 equity. If it shall appear to the satisfaction of the court or justice 14 15 that the respondent has, in fact, violated this section, an injunction 16 may be issued by such court or justice, enjoining and restraining any 17 further violation, without requiring proof that any person has, in fact, 18 been injured or damaged thereby. For the purposes of this subdivision, a 19 person lacks reason to suspect a violation of the penal law, any other
