- AN ACT to amend the election law, in relation to including e-mail addresses in voter registration data

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraphs (k) and (l) of subdivision 5 of section 5-210 of the election law, as amended by chapter 179 of the laws of 2005, subparagraph (xii) of paragraph (k) as added by chapter 362 of the laws of 2008, are amended to read as follows:

5 (k) The form shall also include space for the following information, 6 which must be contained on the inside of the form after it is folded for 7 mailing:

8 (i) A space for the applicant to indicate whether or not he or she has 9 ever voted or registered to vote before and, if so, the approximate year 10 in which such applicant last voted or registered and his or her name and 11 address at the time.

12 (ii) The name and residence address of the applicant including the zip 13 code and apartment number, if any.

14 (iii) <u>A space for the furnishing of an e-mail address, the furnishing</u> 15 <u>of which shall be optional, together with a notice stating that if an</u> 16 <u>e-mail address is furnished, all notices and communications otherwise</u> 17 <u>required to be sent by the state board of elections to the voter by</u>

(1) The mail voter registration application form developed by the 1 2 federal election commission pursuant to the provisions of section nine of the National Voter Registration Act of 1993 42 USC 1973gg-7 shall be 3 deemed to meet the requirements of this section. Any application for 4 5 registration received on such an application form shall be accepted if б the applicant is otherwise eligible to register to vote pursuant to the provisions of this article. <u>A voter whose registration is accepted</u> pursuant to the provisions of this paragraph shall be permitted to 7 8 9 furnish an e-mail address to the board of elections, which furnishing 10 shall carry the same notice and have the same effect as provided by 11 subparagraph (iii) of paragraph (k) of this subdivision.

12 § 2. Paragraph d of subdivision 4 of section 5-500 of the election 13 law, as amended by chapter 659 of the laws of 1994, is amended to read 14 as follows:

15 The residence address at which the voter claims to reside and post d. 16 office address, if not the same; and the number or designation of the 17 room, apartment, or floor occupied by the voter if he or she does not claim the entire building as his or her residence; and in addition, 18 space for the furnishing of an e-mail address, the furnishing of which 19 20 shall be optional, together with a notice stating that if an e-mail 21 address is furnished, all notices and communications otherwise required to be sent by the state board of elections to the voter by postal mail 22 shall be sent by e-mail in addition to postal mail. County boards of 23 24 elections and the board of elections of the city of New York shall have 25 the option of sending notices and communications otherwise required to 26 be sent to the voter by postal mail by e-mail in addition to postal mail 27 if the voter furnishes an e-mail address;

§ 3. This act shall take effect one year after it shall have become a law; provided that the state board of elections is authorized to promulgate any and all rules and regulations and take any other measures necessary to implement this act on its effective date on or before such date.
