Introduced by M. of A. CAHILL -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the executive law, in relation to including the Sawkill Creek in Ulster county within the definition of "inland waterways" for the purposes of waterfront revitalization

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 4 of section 911 of the executive law, as separately
2 amended by chapters 43 and 255 of the laws of 2017, paragraph (a)
3 as separately amended by chapters 133, 135, 140, 153, 234, 265 and 268
4 of the laws of 2018, paragraph (b) as separately amended by chapters 43,
5 142 and 255 of the laws of 2017, and paragraph (c) as separately amended
6 by chapters 131, 140 and 232 of the laws of 2018 is amended to read as
7 follows:

8 4. "Inland waterways" shall mean (a) the state's major inland lakes
9 consisting of lakes Baldwin, Ballston, Big Tupper, Black, Campfire,
10 Canadarago, Canandaigua, Cazenovia, Cayuga, Champlain, Charles, Chateau-
11 gay, Chautauqua, Chazy, Conesus, Cranberry, East Caroga, Dickiebusch,
12 Echo (in the county of Westchester), George, Glencoma, Great Sacandaga,
13 Honeoye, Indian, Katonah, Keuka, Kitchawan, Little Wolf (in the county
14 of Franklin), Lincolndale, Long, Lost (in the county of Putnam),
15 Meahagh, Mirror, MacGregor, Mahopac, Mohegan, Minerva, Northville, Ocea-
16 la, Oneida, Onondaga, Oscaleta, Ossi, Otisco, Otsego, Owasco, Peach,
17 Placid, Purdys, Putnam, Raquette, Rippowam, Ronkonkoma, Round, Sacanda-
18 ga, Saratoga, Schroon, Secor, Seneca, Shenorock, Skaneateles, Silver (in
19 the county of Wyoming), Saranac, Tonetta, Teakettle Spout, Truesdale,
20 Waccabuc, West Caroga and Wixon, Simon (in the county of Franklin) and
21 the Fulton chain of lakes; (b) the state's major rivers comprised of the
22 Allegheny, Ausable, Battenkill, Black, Boquet, Bronx, Canisteo, Chaumont
23 (including Chaumont bay), Chemung, Chenango, Cohocton, Delaware, Deer,
24 Genesee, Grasse, Great Chazy, Hoosic, Hudson north of the federal dam at

1 Troy, Indian, Little (in the Adirondack park), Little Ausable, Little
2 Salmon (including north and south branches), Mad, Mettowee, Mohawk,
3 Oswegatchie, Pocantico, Racquette, Sacandaga, Salmon, Saranac, Saw Mill,
4 Schroon, Susquehanna, Tenmile, Tioga, Tioughnioga, Wallkill and Buffalo
5 rivers, and the north and middle branches of the Moose river; (c) the
6 state's major creeks comprised of the 18 Mile Creek located in Erie
7 county, Chittenango Creek, Bash Bish and Kinderhook Creek located in
8 Columbia county, Kinderhook Creek located in Rensselaer county, Basher
9 Kill, Bushkill, Cattaraugus, Cayadutta, Cincinnati, East Kill, Esopus
10 (including upper and lower branches), Fish (including east and west
11 branches), Gooseberry, Great Valley, Kenyetto, Little Sandy, Onondaga,
12 Peekskill Hollow, Roeliff Jansen Kill, Rondout, Sandy, Schoharie,
13 Shawangunk Kill, South Sandy, Oatka, Tonawanda, West Kill, Scajaquada,
14 Wappinger, Webatuck, Wassaic, Black Creek located in Monroe county,
15 Black Creek located in Genesee and Wyoming counties, Ellicott Creek
16 located in Erie county Wynantskill, Claverack, Taghkanic and Agawamuck
17 and Wyomanock, and Ley Creek and Butternut Creek located in Onondaga
18 county and Sawkill (in Ulster county); (d) the Barge Canal System as
19 defined in section two of the canal law; and (e) the adjacent shorelands
20 to the extent that such inland waters and adjacent lands are strongly
21 influenced by each other including, but not limited to, islands,
22 wetlands, beaches, dunes, barrier islands, cliffs, bluffs and erosion
23 prone areas.

24 § 2. This act shall take effect immediately.
