AN ACT to amend the environmental conservation law, in relation to polystyrene loosefill packaging material

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Article 27 of the environmental conservation law is amended by adding a new title 28 to read as follows:

## TITLE 28

POLYSTYRENE LOOSEFILL PACKAGING MATERIAL

Section 27-2801. Polystyrene loosefill packaging material.

- 7 <u>1. For the purposes of this title, the following definitions shall</u> 8 <u>apply:</u>
- 9 (a) "Manufacturer" means a person who manufactures loosefill packaging
  10 material composed of expanded polystyrene.
- 11 (b) "Recycled material" means material from any of the following that 12 has been diverted from landfill disposal including:
- 13 <u>(i) Material derived from a finished polystyrene product that has</u> 14 <u>completed its intended end use and product life cycle.</u>
- 15 <u>(ii) Material derived from a blemished, flawed, or otherwise unusable</u> 16 <u>finished polystyrene product.</u>
  - (iii) Material derived from manufacturing and fabrication scrap from production of a finished polystyrene product.
- 19 (c) "Wholesaler" means a person who purchases expanded polystyrene 20 loosefill packaging for resale in this state.
- 21 <u>2. Except as provided in subdivision three of this section, on and</u>
  22 <u>after January first, two thousand twenty, a wholesaler or manufacturer</u>
- 23 shall not sell or offer for sale in this state expanded polystyrene
- 24 <u>loosefill packaging material.</u>

3. Subdivision two of this section shall not apply to expanded polystyrene tyrene loosefill packaging material composed of expanded polystyrene that complies with the following requirements:

- 4 (a) On and after January first, two thousand twenty, until December
  5 thirty-first, two thousand twenty-one, inclusive, it is comprised of at
  6 least sixty percent recycled material.
- 7 (b) On and after January first, two thousand twenty-two, until Decem-8 ber thirty-first, two thousand twenty-four, inclusive, it is comprised 9 of at least eighty percent recycled material.
- 10 <u>(c) On and after January first, two thousand twenty-five, it is</u>
  11 <u>comprised of one hundred percent recycled material.</u>
- 12 § 2. This act shall take effect immediately.
