AN ACT to amend the vehicle and traffic law, in relation to increasing the fines associated with passing a stopped school bus by certain vehicles

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision (c) of section 1174 of the vehicle and traffic 2 law, as amended by chapter 254 of the laws of 2002, is amended to read 3 as follows:

4 (c) [Every] 1. Except as otherwise provided in paragraph two of this subdivision, every person convicted of a violation of subdivision (a) of 5 this section shall: for a first conviction thereof, be punished by a б fine of not less than two hundred fifty dollars nor more than four 7 8 hundred dollars or by imprisonment for not more than thirty days or by 9 both such fine and imprisonment; for a conviction of a second violation, 10 both of which were committed within a period of three years, such person 11 shall be punished by a fine of not less than six hundred dollars nor more than seven hundred fifty dollars or by imprisonment for not more 12 13 than one hundred eighty days or by both such fine and imprisonment; upon 14 a conviction of a third or subsequent violation, all of which were committed within a period of three years, such person shall be punished 15 by a fine of not less than seven hundred fifty dollars nor more than one 16 thousand dollars or by imprisonment for not more than one hundred eighty 17 18 days or by both such fine and imprisonment.

Every person convicted of a violation of subdivision (a) of this 20 section while operating a commercial motor vehicle shall: for a first 21 conviction thereof, be punished by a fine of not less than three hundred 22 dollars nor more than four hundred dollars or by imprisonment for not 23 more than thirty days or by both such fine and imprisonment; for a 24 conviction of a second violation, both of which were committed within a
