AN ACT to amend the election law, in relation to application for an absentee ballot

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 1, the opening paragraph of subdivision 2 and  
2 paragraphs (c) and (d) of subdivision 3 of section 8-400 of the election  
3 law, subdivision 1 and paragraphs (c) and (d) of subdivision 3 as  
4 amended by chapter 63 of the laws of 2010, paragraph (c) of subdivision  
5 1 and subparagraph (iii) of paragraph (c) of subdivision 3 as amended by  
6 chapter 375 of the laws of 2015, and the opening paragraph of subdivi-  
7 sion 2 as amended by chapter 216 of the laws of 1988, are amended to  
8 read as follows:

9 1. A qualified voter may vote as an absentee voter under this chapter  
10 if [~~on the occurrence of any village election conducted by the board of~~  
11 ~~elections, primary election, special election, general election or New~~  
12 ~~York city community school board district or city of Buffalo school~~  
13 ~~district election,~~] he or she expects to be [+

14 ~~(a) absent from the county of his or her residence, or, if a resident~~  
15 ~~of the city of New York absent from said city, or~~

16 ~~(b) unable to appear personally at the polling place of the election~~  
17 ~~district in which he or she is a qualified voter because of illness or~~

5 A qualified voter desiring to vote [~~at such election~~] as an absentee  
6 voter for any reason [~~specified in subdivision one hereof~~] must make  
7 application for an absentee ballot on a form to be obtained and filed as

10 (c) [~~A statement, as appropriate, that on the day of such election the~~

28 ~~(d)~~] Such application shall permit the applicant to apply for an  
29 absentee ballot for either a primary election or the general election in  
30 any year and for those persons who will be continuously absent from  
31 their county of residence during the period between the fall primary  
32 election and the general election in any year to apply for ballots for  
33 both such elections in such year. A voter who applies for an absentee  
34 ballot shall be sent an absentee ballot for any special election or  
35 winter primary that occurs during the period of absence specified in the  
36 application.

37 § 2. This act shall take effect on the ninetieth day after it shall  
38 have become a law.
