AN ACT to amend the workers' compensation law, in relation to physical therapy care provided through the workers' compensation system

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (d) of subdivision 1 of section 13-b of the workers' compensation law, as amended by chapter 473 of the laws of 2000, is amended to read as follows: (d) Upon the referral which may be directive as to treatment of an
