AN ACT to amend the executive law, in relation to unlawful discriminatory practices by government agencies relating to persons recovering from alcohol and/or substance abuse

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The executive law is amended by adding a new section 296-e 2 to read as follows:
- § 296-e. Unlawful discriminatory practices by government agencies 4 relating to persons recovering from alcohol and/or substance abuse. 1. 5 For the purposes of this section:
- 6 (a) "Government agency" shall mean any department, division, board,
 7 bureau, commission, office, agency, correctional facility, authority or
 8 public corporation of the state or a county, city, town or village
 9 government or any other instrumentality of local government or public
 10 educational institution.
- 11 (b) "Alcohol abuse" and/or "substance abuse" shall have the same mean-12 ings as set forth in section 1.03 of the mental hygiene law.
- 2. It shall be an unlawful discriminatory practice for a government agency employer to deny employment to a prospective employee solely on
- 15 the basis that such prospective employee is recovering from alcohol
- 16 <u>and/or substance abuse.</u>
- 17 § 2. This act shall take effect immediately.
