AN ACT to amend the public authorities law, in relation to public notice before approval of utility transmission facilities

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1020-ii of the public authorities law, as added by a chapter of the laws of 2018 amending the public authorities law relating to requiring the Long Island Power Authority to provide public notice for the construction of utility transmission facilities, as proposed in legislative bill numbers S.6861-A and A.8609-A, is amended to read as follows:

- § 1020-ii. Public notice before approval of utility transmission facilities. 1. As used in this section, the following terms shall have the following meanings:
- 10 (a) "municipality" means a county, city, town or village in the 11 service area;

- 12 (b) "utility transmission facility" means any electric transmission
  13 line operating at sixty-five kilovolts or higher in the service area,
  14 including associated equipment. It shall not include any transmission
  15 line which is an in-kind replacement or which is located wholly under16 ground. This section also shall not apply to any major utility trans17 mission facility subject to the jurisdiction of article seven of the
  18 public service law; and
- 19 (c) "[utility] authority customer" means the customer of record 20 located within five hundred feet of a proposed utility transmission 21 facility.
- 22 2. The authority shall not construct any utility transmission facility without first providing public notice as provided by this subdivision.
- 24 Such public notice shall be provided by the authority before the envi-25 ronmental significance of such action is determined by the authority,

pursuant to article eight of the environmental conservation law. The public notice shall provide the following information:

- (a) the location of the site or right-of-way;
- (b) a description of the transmission facility to be built thereon;
- (c) [the environmental aggessment or environmental impact statement prepared for the action, pursuant to article eight of the environmental conservation law;
- (d) a summary of any studies including an environmental assessment or environmental impact statement pursuant to article eight of the environmental conservation law which have been made of the environmental impact of the project, and a description of such studies;
  - $\left[\begin{array}{c} \left(\begin{array}{c} \bullet\end{array}\right)\end{array}\right]$  (d) a statement explaining the need for the facility;
- [<del>(f)</del>] <u>(e)</u> a description of any reasonable alternate location or locations **assessed** for the proposed facility;
- [(g)] (f) a description of the comparative merits and detriments of 16 each location submitted; and
  - [(h)] (g) a statement of the reasons why the primary proposed location is best suited for the facility.
- [Copies] When completed, copies of the environmental assessment form, 20 environmental impact statement and studies referred to in the notice shall be filed with the authority and shall be available for public inspection.
  - 3. Notice shall be provided by first class mail to:
  - (a) each municipality in which any portion of such facility is to be located, both as primarily proposed and in the alternative locations listed. Notice to a municipality shall be addressed to the chief executive officer thereof;
  - (b) each member of the legislature through whose district the utility transmission facility or any alternate proposed [in the application] would pass; and
    - (c) each [utility] authority customer.
- 2. This act shall take effect on the same date and in the same 33 manner as a chapter of the laws of 2018 amending the public authorities law relating to requiring the Long Island Power Authority to provide 35 public notice for the construction of utility transmission facilities, 36 as proposed in legislative bill numbers S.6861-A and A.8609-A, takes 37 effect.
