AN ACT to require the empire state development corporation to create a plan regarding multi-use trails

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. (a) For the purposes of this act, the term "multi-use 2 trail" shall mean an off-street linear facility for recreation and transportation, paved or unpaved, designated to serve multiple types of users, including, but not limited to, bicyclists, pedestrians, in-line skaters, joggers, cross-country skiers or equestrians.

- (b) The empire state development corporation shall create a plan for a comprehensive statewide system of multi-use trails consisting of a network of primary corridors linked to and enhanced by regional and local multi-use trails. The draft plan shall be completed one year after 10 this act becomes a law. The empire state development corporation shall 11 consult concurrently with representatives from the office of parks, 12 recreation and historic preservation, the department of environmental 13 conservation, the department of health and the department of transporta-14 tion to create such plan. A representative of each agency shall be 15 appointed by the commissioner of their respective agency. The empire state development corporation shall meet with the representatives of such agencies at least quarterly. There shall be a sixty-day public 17 comment period on such draft plan and there shall be at least one public hearing on the draft plan during such sixty-day public comment period. 19 20 The final plan shall be completed and adopted one hundred eighty days after submission of the draft plan. The plan shall be updated no less 22 than every five years. Such plan shall include five major components:
- (i) A vision for a statewide network of primary corridors linked to 23 24 and enhanced by regional and local multi-use trails, which will include 25 trail uses to be addressed in the plan; goals for geographic distrib-

1 ution; goals for universal accessibility; and general goals for new trail acquisition and development.

- (ii) A Geographic Information System (GIS) inventory of existing 4 multi-use trails across the state, as well as planned multi-use trails, or undeveloped corridors under consideration for future multi-use trails.
  - (iii) Identification of new multi-use trail opportunities including, but not limited to, transportation (rail, canal, trolley) corridors existing, abandoned or under consideration to be abandoned; under-utilized or closed roads; utility corridors and natural corridors such as waterways and waterfronts.
- (iv) A comprehensive set of multi-use trail recommendations, including 13 but not limited to acquisition and development priorities; guidelines for design and maintenance of different "tier" (primary, regional, local) multi-use trails; guidelines for wayfinding, marketing and inter-16 pretive signs and informational resources, such as statewide and regional maps of existing multi-use trails, to promote the use of such trails and their coordination with other tourism opportunities in New York state.
- 20 (v) Recommendations for funding the acquisition, construction, mainte-21 nance, and promotion of multi-use trails as well as implementation.
- (c) The office of parks, recreation and historic preservation, the department of environmental conservation, the department of health, the 23 24 department of transportation and any other state agencies, departments, 25 public authorities or programs with relevant expertise or resources shall provide the empire state development corporation with such facili-27 ties, assistance, and data as will enable the empire state development corporation to carry out its powers and duties. The empire state devel-28 29 opment corporation will have primary responsibility for implementation 30 of the plan created pursuant to the provisions of this act, provided the 31 costs of implementation have been appropriated or identified by the 32 chairperson of the empire state development corporation.
  - § 2. This act shall take effect immediately.
