AN ACT to amend the vehicle and traffic law, in relation to authorizing a residential parking system in certain parts of the hamlet of Ocean-side in the Town of Hempstead

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 2 of section 1662-e of the vehicle and traffic law, as added by chapter 267 of the laws of 2013, is amended to read as follows:

- 2. Such residential parking permit system may only be established
- 5 <u>(i)</u> within the area known as East Meadow of the town consisting of the following roadways:
 - (a) Roosevelt Avenue west of Prospect Avenue;
 - (b) Jefferson Street west of Prospect Avenue;
 - (c) First Street west of Prospect Avenue;
- 10 (d) Second Street West of Prospect Avenue;
- 11 (e) Third Street west of Prospect Avenue;
- 12 (f) Fourth Street west of Prospect Avenue;
- 13 (g) Clearmeadow Drive;
- 14 (h) Nottingham Road;
- 15 (i) Florence Court;
- 16 (j) Jane Court;

- 17 (k) Dofena Lane;
- 18 (1) Franklin Avenue north of 4th Street;
- 19 (m) Bailey Avenue;
- 20 (n) Franklin Avenue, north of 7th Street and south of Hempstead Turn-21 pike;
- 22 (o) Lincoln Avenue, north of 7th Street and south of Roosevelt Avenue;
- 23 (p) 5th Street, west of Prospect Avenue;
- 24 (q) 6th Street, west of Prospect Avenue;
