AN ACT to amend the education law, in relation to the New York state district attorney and indigent legal services attorney loan forgiveness program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph b of subdivision 2 of section 679-e of the education law, as amended by section 1 of part VV of chapter 56 of the laws of 2009, is amended to read as follows:

2 b. "Eligible period" means the six-year period after completion of the
3 third year and before the commencement of the tenth year of employment
4 as an eligible attorney. For purposes of this section, all periods of
5 time during which an admitted attorney was employed as an eligible
6 attorney and all periods of time during which a law school graduate
7 awaiting admission to the New York state bar was employed by a prosecuting or criminal defense agency as permitted by section four hundred
8 eighty-four of the judiciary law shall be combined. A period of leave
9 without pay, or other periods which an eligible attorney is not in a pay
10 status shall not count toward the completion of required service period
11 reemployment. The service completion date shall be extended by the total
12 time spent in non-pay status. However, absence because of uniformed
13 service with a recognized branch of the United States military, authorized maternity/paternity, FMLA, or due to compensable injury shall be
14 considered creditable, within the sole discretion of the president,
15 toward the required service period upon reemployment.

16 § 2. This act shall take effect immediately and shall be deemed to
17 have been in full force and effect on and after January 1, 2010.
