AN ACT to amend the environmental conservation law, in relation to regulation of toxic chemicals in children's products

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Article 37 of the environmental conservation law is amended by adding a new title 9 to read as follows:

13 As used in this title, unless the context otherwise indicates, the 14 following terms have the following meanings.

- 15 1. "Children's apparel" means any item of clothing that consists of
  16 fabric or related material intended or promoted for use in children's
  17 clothing. Children's apparel does not mean protective equipment designed
  18 to prevent injury, including, but not limited to, bicycle helmets,
  19 athletic supporters, knee pads or elbow pads.
- 20 2. "Chemical" means a substance with a distinct molecular composition
  21 or a group of structurally related substances and includes the breakdown
  22 products of the substance or substances that form through decomposition,
  23 degradation or metabolism.
- 24 <u>3. "Chemicals of concern" means:</u>
- 25 (a) 1,1,2,2-Tetrachloroethane (CAS 79-34-5)

- (b) The department, in consultation with the department of health, may identify a chemical as a dangerous chemical if, upon such review, it is present in a children's product and meets any of the following criteria:
- 6 (i) The chemical or its metabolites have been found through biomoni-7 toring to be present in humans;
- 8 <u>(ii) The chemical has been found through sampling and analysis to be</u>
  9 <u>present in household dust, indoor air, drinking water or elsewhere in</u>
  10 <u>the home environment;</u>
- 11 (iii) The chemical has been found through monitoring to be present in 12 fish, wildlife or the natural environment; or
- 13 <u>(iv) The sale or use of the chemical or a children's product contain-</u>
  14 <u>ing the chemical has been banned in another state or states within the</u>
  15 <u>United States because of the health effects of such chemical.</u>
  - (c) The department, in consultation with the department of health, may remove a chemical from the list of dangerous chemicals if, upon review, it determines on the basis of credible scientific evidence that such chemical no longer meets the criteria for listing under paragraph (b) of this subdivision.
- 21 (d) The department, in consultation with the department of health
  22 shall identify a chemical as a chemical of concern if, upon review, it
  23 determines that the chemical has been identified by a state, federal or
  24 international governmental entity on the basis of credible scientific
  25 evidence as:
- 26 <u>(i) A carcinogen, reproductive or developmental toxicant, neurotoxi-</u> 27 <u>cant, asthmagen, or endocrine disruptor;</u>
  - (ii) Persistent, bioaccumulative and toxic; or
  - (iii) Very persistent and very bioaccumulative.
- 30 § 37-0905. Reporting on the use of chemicals.
- 1. Reporting of chemical use. No later than twelve months after a dangerous chemical appears on the list published pursuant to section 37-0903 of this title, every manufacturer who offers a children's product for sale or distribution in this state that contains a dangerous chemical or chemical of concern shall report such chemical use at practical quantification limits to the department.
  - (a) This report must at a minimum identify the children's product, the dangerous chemical or chemicals of concern contained in the children's product and the intended purpose of such chemicals. The department may also require reporting of the following information:
    - (i) the amount of such chemical in the children's product; or
  - (ii) information on the likelihood that the chemical will be released from the children's product to the environment during the product's life cycle and the extent to which users of the product are likely to be exposed to the chemical.
  - (b) The department is authorized to direct submission of such report to the interstate chemicals clearinghouse.
- 48 2. Waiver of reporting. Upon application by a manufacturer, the commissioner may waive all or part of the reporting requirements under 49 subdivision one of this section for one or more specified uses of a 50 51 dangerous chemical. In making such determination, the commissioner may consider: (a) if substantially equivalent information is already public-52 ly available or that the information is not needed for the purposes of 53 this chapter, (b) similar waivers granted by other states, and (c) 54 55 whether the specified use or uses are minor in volume.

3. Notice. (a) A manufacturer of a children's product containing a dangerous chemical shall notify persons that offer the children's product for sale or distribution in the state, in a form prescribed by the department, of the presence of such dangerous chemical, and provide such persons with information regarding the toxicity of such chemical.

- (b) The department shall notify consumers about children's products containing chemicals of concern and dangerous chemicals. The notification shall be published on the department's website.
- 4. Fees. The manufacturer shall pay a fee upon submission of a report of chemical use pursuant to subdivision one of this section or a waiver request pursuant to subdivision two of this section to cover the department's reasonable costs in the administration and enforcement of this title. Exclusive of fines and penalties, the state shall only recover its actual cost of administration and enforcement.
- § 37-0907. Sales prohibition.
- 1. Effective January first, two thousand twenty-three, no person shall distribute, sell or offer for sale in this state a children's product containing tris (1, 3 dichloro-2-propyl) phosphate, benzene, lead and compounds (inorganic), mercury and mercury compounds including methyl mercury, formaldehyde, asbestos, arsenic and arsenic compounds including arsenic trioxide and dimethyl arsenic, organohalogen flame retardents, and cadmium. This provision shall not apply to a children's product solely based on its containing an enclosed battery or enclosed electronic components. The commissioner may exempt a children's product from this prohibition if, in the commissioner's judgment, the lack of availability of the children's product could pose an unreasonable risk to public health, safety or welfare.
- 2. Effective three years after being added to the dangerous chemicals list, no person shall distribute, sell, or offer for sale in this state a children's product that contains a chemical added to the dangerous chemicals list pursuant to section 37-0903 of this title. This provision shall not apply to a children's product solely based on its containing an enclosed battery or enclosed electronic components. The commissioner may exempt a children's product from this prohibition if, in the commissioner's judgment, the lack of availability of the children's product could pose an unreasonable risk to public health, safety or welfare.
  § 37-0909. Applicability.
- 1. New children's products. The provisions of this title shall apply to chemicals in children's products sold or distributed as new and does not apply to used children's products that are sold or distributed for free at secondhand stores, yard sales, on the internet or donated to charities.
- 2. Industry. The requirements of this title shall not apply to priority chemicals used in or for industry or manufacturing, including chemicals processed or otherwise used in or for industrial or manufacturing processes and not included in the final product.
- 3. Transportation. The requirements of this title shall not apply to
  motor vehicles or their component parts, watercraft or their component
  parts, all terrain vehicles or their component parts, or off-highway
  motorcycles or their component parts, except that the use of dangerous
  chemicals in detachable car seats is not exempt.
- 4. Combustion. The requirements of this title shall not apply to
  dangerous chemicals generated solely as combustion by-products or that
  are present in combustible fuels.

5. Exceptions. The requirements of this title shall not apply to children's product makers that employ five persons or fewer, and are inde-3 pendently owned and operated.

- 6. Retailers. A retailer is exempt from the requirements of this title unless that retailer knowingly sells a children's product containing a dangerous chemical after the effective date of its prohibition for which that retailer has received notification pursuant to subdivision three of section 37-0905 of this title.
- 9 § 37-0911. Enforcement and implementation.
- 10 1. Failure to provide notice. A children's product containing a 11 dangerous chemical may not be sold, offered for sale or distributed for sale in this state unless the manufacturer has provided the notification 12 13 required under section 37-0905 of this title by the date required in such section. The commissioner may exempt a children's product from this 14 prohibition if, in the commissioner's judgment, the lack of availability 15 16 of the children's product could pose an unreasonable risk to public 17 health, safety or welfare.
- 2. Statement of compliance. If there are grounds to suspect that a 18 19 children's product is being offered for sale in violation of this title, 20 the department may request the manufacturer of the children's product to 21 provide a statement of compliance on a form provided by the department, within ten days of receipt of a request from the department. The state-22 23 ment of compliance shall:
- (a) attest that the children's product does not contain the dangerous 24 25 chemical; or
- 26 (b) attest and provide the department with documentation that notifi-27 cation of the presence of the dangerous chemical has been provided to the department or provide notice as required by section 37-0905 of this 28 29 title; or
- 30 (c) attest that the manufacturer has notified persons who sell the 31 product in this state that the sale of the children's product is prohib-32 ited.

- 34 The department may adopt any rules and regulations it deems necessary 35 to implement the provisions of this title.
- § 2. This act shall take effect March 1, 2020. Effective immediately, 36 the department of environmental conservation is authorized to implement 37 rules and regulations for the timely implementation of this act on its 38
- 39 effective date.
