- AN ACT to amend the public health law and the education law, in relation to prohibiting the performance of a pelvic examination on an anesthetized or unconscious person

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. Section 2504 of the public health law is amended by adding
2	a new subdivision 7 to read as follows:
3	7. No person shall perform a pelvic examination or supervise the
4	performance of a pelvic examination on an anesthetized or unconscious
5	patient unless the person performing the pelvic examination is legally
б	authorized to do so and the person supervising the performance of the
7	pelvic examination is legally authorized to do so and:
8	(a) the patient or the patient's authorized representative gives prior
9	oral or written informed consent specific to the pelvic examination;
10	(b) the performance of a pelvic examination is within the scope of
11	care for the surgical procedure or diagnostic examination scheduled to
12	be performed on the patient and to which the patient has already given
13	<u>oral or written consent; or</u>
14	(c) the patient is unconscious and the pelvic examination is medically
15	necessary for diagnostic or treatment purposes, and the patient is in
16	immediate need of medical attention and an attempt to secure consent
