AN ACT to amend the criminal procedure law and the education law, in relation to expanding the geographical area of employment of university police officers; and to repeal paragraph (d) of subdivision 34-a of section 1.20 of the criminal procedure law relating thereto

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (a) of subdivision 34-a of section 1.20 of the criminal procedure law, as amended by chapter 428 of the laws of 1999, is amended to read as follows:

(a) [~~Except as provided in paragraph (d) of this subdivision,~~] New York state constitutes the "geographical area of employment" of any police officer employed as such by an agency of the state or by an authority which functions throughout the state, or a police officer designated by the superintendent of state police pursuant to section two hundred twenty-three of the executive law;

§ 2. Paragraph (a) of subdivision 34-a of section 1.20 of the criminal procedure law, as amended by chapter 424 of the laws of 1998, is amended to read as follows:

(a) [~~Except as provided in paragraph (d),~~] New York state constitutes the "geographical area of employment" of any police officer employed as such by an agency of the state or by an authority which functions throughout the state;

§ 3. Paragraph (d) of subdivision 34-a of section 1.20 of the criminal procedure law is REPEALED.

§ 4. Paragraph 1 of subdivision 2 of section 355 of the education law, as amended by chapter 424 of the laws of 1998, is amended to read as follows:

1. To appoint university police officers who shall have the powers of police officers and to remove such police officers at pleasure;

1 provided, however, that any person appointed a police officer must have
2 satisfactorily completed or complete within one year of the date of his

13 cols shall not be deemed to supersede the authority of other police
14 officers. The provisions of this paragraph shall not apply to any of
15 the state institutions and property referred to in section five thousand
16 seven hundred nine of this chapter.

17 § 5. This act shall take effect immediately; provided, however, that
18 the amendments to paragraph (a) of subdivision 34-a of section 1.20 of
19 the criminal procedure law made by section one of this act shall be
20 subject to the expiration and reversion of such paragraph pursuant to
21 section 3 of chapter 428 of the laws of 1999, as amended, when upon such
22 date the provisions of section two of this act shall take effect.
