AN ACT to amend the insurance law, in relation to mandating commercial insurance coverage of peer support services as part of treatment for substance use disorder

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraph (A) of paragraph 31 of subsection (i) of 2 section 3216 of the insurance law, as added by chapter 41 of the laws of 3 2014, is amended to read as follows:

4 (A) Every policy that provides medical, major medical or similar comprehensive-type coverage must provide outpatient coverage for the 5 diagnosis and treatment of substance use disorder, including detoxifica-6 7 tion and rehabilitation services and also including peer support 8 services provided by a certified recovery peer advocate as defined by 9 the office of alcoholism and substance abuse services. Such coverage 10 shall not apply financial requirements or treatment limitations to 11 outpatient substance use disorder benefits that are more restrictive than the predominant financial requirements and treatment limitations 12 applied to substantially all medical and surgical benefits covered by 13 14 the policy. Further, such coverage shall be provided consistent with 15 the federal Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 (29 U.S.C. § 1185a). 16

17 § 2. Subparagraph (A) of paragraph 31 of subsection (i) of section 18 3216 of the insurance law, as amended by section 6 of subpart A of part 19 BB of chapter 57 of the laws of 2019, is amended to read as follows:

Such coverage 46 shall not apply financial requirements or treatment limitations to 47 outpatient substance use disorder benefits that are more restrictive 48 than the predominant financial requirements and treatment limitations applied to substantially all medical and surgical benefits covered by 49 the contract. Further, such coverage shall be provided consistent with 50 51 the federal Paul Wellstone and Pete Domenici Mental Health Parity and Addiction Equity Act of 2008 (29 U.S.C. § 1185a). 52

53 § 6. Paragraph 1 of subsection (1) of section 4303 of the insurance 54 law, as amended by section 27 of subpart A of part BB of chapter 57 of 55 the laws of 2019, is amended to read as follows:

(1) Every contract that provides medical, major medical or similar 1 comprehensive-type coverage shall provide outpatient coverage for the 2 diagnosis and treatment of substance use disorder, including detoxifica-3 4 tion and rehabilitation services and also including peer support services provided by a certified recovery peer advocate as defined by 5 б the office of alcoholism and substance abuse services. Such coverage shall not apply financial requirements or treatment limitations to outpatient substance use disorder benefits that are more restrictive 7 8 than the predominant financial requirements and treatment limitations 9 applied to substantially all medical and surgical benefits covered by 10 11 the contract. 7. have become a law; provided that the amendments to subparagraph (A) of 13 14 paragraph (31) of subsection (i) of section 3216 of the insurance law 15 made by section two of this act, the amendments to subparagraph (A) of 16 paragraph (7) of subsection (1) of section 3221 of the insurance law 17 made by section four of this act and the amendments to paragraph (1) of subsection (1) of section 4303 of the insurance law made by section six 18 of this act shall take effect on the same date and in the same manner as 19 20 subpart A of part BB of chapter 57 of the laws of 2019, takes effect.
