AN ACT to amend chapter 450 of the laws of 2018, authorizing the city of Albany to alienate certain lands used as parkland and to dedicate certain other lands as parklands, in relation to revising the metes and bounds of the parkland property to be alienated

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Section 3 of chapter 450 of the laws of 2018, authorizing the city of Albany to alienate certain lands used as parkland and to dedicate certain other lands as parklands, is amended to read as 4 follows:
- 5 § 3. The parklands authorized by section one of this act to be discon-6 tinued as parklands are described as follows:
- 7 ALL that certain piece or parcel of land located in the City of Albany, 8 County of Albany, State of New York and being more particularly bounded 9 and described as follows:
- 10 Parcel 1
- 11 Commencing at a point on the westerly street boundary of Martin Luther
- 12 King Jr. Boulevard at its intersection with the southerly street bounda-
- 13 ry of Park Avenue and running along the said westerly street boundary of
- 14 Martin Luther King Jr. Boulevard a distance of 235± feet to the point of
- 15 beginning of the herein described Parkland Alienation Parcel 1; thence
- 16 continuing along said westerly street boundary of Martin Luther King Jr.
- 17 Boulevard the following two (2) courses and distances:
- 18 1. South 24°31'32" West, a distance of 9.53 feet to a point of curva-19 ture; and
- 20 2. along a curve to the left having a radius of 308.00 feet, an arc
- 21 length of 47.87 feet and a chord of South 20°04'22" West, a distance of
