AN ACT to authorize the town of New Hartford, in the county of Oneida, to alienate certain parklands and to dedicate other lands as parklands

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the town of New 2 Hartford, in the county of Oneida, acting by and through its governing body and upon such terms and conditions as determined by such board is hereby authorized to discontinue as parklands and alienate the lands described in section three of this act for the purpose of the installation and operation of a cell tower base station facility.

- § 2. The authorization provided in section one of this act shall be effective only upon the condition that the town of New Hartford dedicates the lands described in section four of this act as parkland 10 provided that the town of New Hartford has never used such lands for public open space or park purposes.
- 12 § 3. The parklands authorized by section one of this act to be alien-13 ated are described as follows:

4 ALL THAT LOT OR PARCEL OF LAND in Village of New York Mills, Town of 5 New Hartford, County of Oneida, State of New York, bounded and described 6 as follows:

Beginning at a point in the easterly fence line of Henderson Street to the northwest corner of a parcel of land conveyed by the New York Mills Corporation to Arthur D. Cheetham, thence north 14° West forth (40) feet along said easterly line to an iron pipe; thence north 56° 34' east one hundred sixty-six and sixty seven hundredths (166.67) feet to a corner, thence south 35° 30' east forth two (42) feet to the northeast corner of said Cheetham parcel, thence south 57° 55' west one hundred eighty-one and fifty-five hundredths (181.55) feet along the northerly boundary of said Cheetham parcel to the place of beginning. Containing an area of 0.16 acres, more or less.

- § 5. In the event that the fair market value of the parklands described in section four of this act to be dedicated as parkland by the town of New Hartford pursuant to this act are not equal to or greater than the fair market value of the parklands to be alienated as described in section three of this act, the town of New Hartford shall dedicate the difference of the fair market value of the lands to be alienated and the lands to be dedicated for the acquisition of additional parklands and/or capital improvements to existing park and recreational facilities.
- 26 In the event that the town of New Hartford received any funding 27 support or assistance from the federal government for the purchase, maintenance or improvement of the parklands set forth in section three 28 29 of this act, the discontinuance and alienation of such parkland author-30 ized by the provisions of this act shall not occur until the town of New 31 Hartford has complied with any federal requirements pertaining to the alienation or conversion of parklands, including satisfying the secre-33 tary of the interior that the alienation or conversion complies with all 34 conditions which the secretary of the interior deems necessary to assure 35 the substitution of other lands shall be equivalent in fair market value 36 and usefulness to the lands being alienated or converted.
  - § 7. This act shall take effect immediately.
