Introduced by M. of A. ABBATE -- read once and referred to the Committee on Governmental Employees

AN ACT to amend the military law, in relation to age requirements applicable to appointments or promotions of public employees in cities with a population of one million or more who have been absent on military duty

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 10-a of section 243 of the military law, as
2 amended by chapter 278 of the laws of 1994, is amended to read as
3 follows:

4 10-a. Age requirements. If maximum age requirements are established by
5 law, or rule or by action of a civil commission for examination for, or
6 for appointment or promotion to, any position in the public service, the
7 period of military duty as hereinbefore defined, the period of service
8 after June twenty-seventh, nineteen hundred fifty, voluntarily entered
9 upon between January first, nineteen hundred forty-seven, and June twenty-seventh, nineteen hundred fifty, if such service otherwise falls
10 within the definition of military duty, and the period of terminal leave
11 granted by the military authorities of a candidate or eligible shall not
12 be included in computing the age of such candidate or eligible for the
13 purposes of such examination or appointment or promotion; provided,
14 however, that neither shall the total time deducted hereunder in computing the age of a candidate or eligible exceed six years, except that in
15 cities with a population of one million or more, the total time deducted
16 shall not exceed seven years.
