Introduced by M. of A. LIFTON -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the environmental conservation law, in relation to authorizing hunting big game by rifle in the county of Tompkins

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph a of subdivision 2 of section 11-0907 of the  
2 environmental conservation law is amended by adding a new item (o) to  
3 read as follows:

4 <u>(o) The county of</u>	<u>Deer, the first</u>	<u>Pistol, shotgun,</u>
5 <u>Tompkins</u>	<u>Saturday after November</u>	<u>crossbow, muzzle</u>
6	<u>15 through first Sunday</u>	<u>loading firearm,</u>
7	<u>after December 7</u>	<u>rifle or long bow</u>

8 § 2. Item (f) of paragraph a of subdivision 2 of section 11-0907 of  
9 the environmental conservation law, as separately amended by chapters  
10 125 and 243 of the laws of 2017, is amended to read as follows:

11 (f) Southern tier,	Deer, first	Pistol, shotgun,
12 central and Western	Monday after November	crossbow,
13 region, except those	15 through first	muzzle loading
14 counties or portions	Tuesday after	firearm or
15 thereof listed in	December 7	long bow only

1 § 3. Paragraph a of subdivision 2 of section 11-0907 of the environ-

9 § 4. Item (f) of paragraph a of subdivision 2 of section 11-0907 of  
 10 the environmental conservation law, as separately amended by chapters  
 11 125, 133, 204, and 243 of the laws of 2017, is amended to read as  
 12 follows:

13 (f) Southern tier,	Deer and bear, first	Pistol, shotgun,
14 central and Western	Monday after November	crossbow, muzzle
15 region, except those	15 through first	loading firearm

21 § 5. This act shall take effect immediately, provided that:

22 a. the amendments to paragraph a of subdivision 2 of section 11-0907  
 23 of the environmental conservation law made by section one of this act  
 24 shall be subject to the expiration and reversion of such paragraph  
 25 pursuant to section 13 of chapter 600 of the laws of 1993, as amended;

26 b. the amendments to item (f) of paragraph a of subdivision 2 of  
 27 section 11-0907 of the environmental conservation law made by section  
 28 two of this act shall be subject to the expiration and reversion of such  
 29 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as  
 30 amended; and

31 c. sections three and four of this act shall take effect upon the  
 32 expiration and reversion of paragraph a of subdivision 2 of section  
 33 11-0907 of the environmental conservation law, as provided in section 13  
 34 of chapter 600 of the laws of 1993, as amended.
