AN ACT to amend the environmental conservation law, in relation to the Central Pine Barrens area and the core preservation area

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivisions 10 and 11 of section 57-0107 of the environ-
2 mental conservation law, as amended by a chapter of the laws of 2019
3 amending the environmental conservation law relating to the Central Pine
4 Barrens area and the core preservation area, as proposed in legislative
5 bills numbers S. 6357 and A. 8135, are amended to read as follows:

6 10. "Central Pine Barrens area" shall mean the contiguous area as
7 described and bounded as follows:

8 Beginning at a point where the southerly side of Route 25A intersects
9 the easterly side of Miller Place Road; thence southward along the east-
10 erly boundary of Miller Place Road to Helme Avenue; thence southward
11 along the easterly boundary of Helme Avenue to Miller Place-Middle
12 Island Road; thence southward along the easterly boundary of Miller
13 Place-Middle Island Road to Whiskey Road; thence westward along the
14 southerly boundary of Whiskey Road to Mount Sinai-Coram Road; thence
15 southward along the easterly boundary of Mount Sinai-Coram Road to
16 Middle Country Road (Route 25); thence westward along the southerly
17 boundary of Route 25 to Patchogue-Mount Sinai Road (County Route 83);
18 thence southward along the easterly boundary of County Route 83 to Bicy-
19 cle Path Drive; thence southeastward along the easterly side of Bicycle
20 Path Drive to Mt. McKinley Avenue; thence southward along the easterly
21 boundary of Mt. McKinley Avenue to Granny Road; thence northeastward
22 along the northerly boundary of Granny Road to Port Jefferson-Patchogue
23 Road (Route 112); thence southward along the easterly boundary of Route
24 112 to Horse Block Road (County Route 16); thence eastward along the
25 northerly boundary of County Route 16 to Maine Avenue; thence northward
26 along the westerly boundary of Maine Avenue to Fire Avenue; thence east-
27 ward along the northerly boundary of Fire Avenue to John Roe Smith
28 Avenue; thence southward along the easterly boundary of John Roe Smith

1 Avenue to Jeff Street; thence eastward along the northerly boundary of
2 Jeff Street to Hagerman Avenue; thence southward along the easterly
3 boundary of Hagerman Avenue to the Long Island Expressway (Route 495);
4 thence eastward along the northerly boundary of Route 495 to the westerly
5 side of Yaphank Avenue (County Road 21); thence southward along the
6 westerly side of Yaphank Avenue to the south side of the Long Island
7 Expressway (Route 495); thence eastward along the southerly side of the
8 Long Island Expressway (Route 495) to the easterly side of Yaphank
9 Avenue; thence southward along the easterly side of Yaphank Avenue,
10 crossing Sunrise Highway (Route 27) to the south side of Montauk Highway
11 (County Road 80); thence southwestward along the south side of Montauk
12 Highway (County Road 80) to South Country Road; thence southward along
13 the easterly side of South Country Road to Fireplace Neck Road; thence

16 westerly boundary of the Carmans River and the lands owned by the United
17 States known as Wertheim National Wildlife Refuge (the "Refuge"); thence
18 generally westerly and southerly to the waters of Bellport Bay; thence
19 generally easterly across the Bay and northerly along the easterly boundary
20 of the Refuge, including all lands currently part of the Refuge and
21 any lands which may become part of the Refuge in the future, to the east
22 side of the southern terminus of Smith Road; thence northward along the
23 easterly side of Smith Road to the southwesterly corner of the property
24 identified as District 200, Section 974.50, Block 1, Lot 11; thence
25 eastward, northward and westward in a counter-clockwise direction along
26 the southern, eastern and northern boundaries of that property to the
27 easterly side of Smith Road; thence northward along the east side of
28 Smith Road to Merrick Road; thence northeasterly along the northerly
29 side of Merrick Road to the easterly side of Surrey Circle and the
30 southwest corner of the property identified as District 200, Section
31 880, Block 3, Lot 58.1; running thence easterly along the southerly side
32 of said lot to the west side of William Floyd Parkway (County Road 46);
33 thence northerly along the westerly side of William Floyd Parkway (County
34 Road 46), crossing Route 27, to the Long Island Railroad (LIRR);
35 thence eastward along the northerly boundary of the Long Island Rail
36 Road tracks 7,500 feet; thence southward 500 feet; thence eastward 525
37 feet to the intersection of North Street and Manor-Yaphank Road; thence
38 southward along the easterly boundary of Manor-Yaphank Road to Moriches-
39 Middle Island Road; thence eastward along the northerly boundary of
40 Moriches-Middle Island Road to a point due north of the easterly boundary

45 said property to its intersection with property identified as District
46 200, Section 712, Block 9, Lot 1; thence generally southward along the
47 westerly boundary of said property to its intersection with the northerly
48 side of the eastward extension of Grove Drive, known as Grove Street;
49 thence southward crossing Grove Street to its south side; thence westward
50 along the southerly boundary of the Grove Street road extension to
51 the northwestern corner of the property identified as District 200,
52 Section 749, Block 3, Lot 41.1; and comprised of parcels owned by the
53 county of Suffolk and the town of Brookhaven; thence southward to the
54 southwestern corner of property identified as District 200, Section 749,
55 Block 3, Lot 43; thence eastward along the southerly boundary of said
56 property to the west side of Lambert Avenue; thence crossing Lambert

1 Avenue to its easterly side; thence southward along the easterly bounda-
2 ry of Lambert Avenue to the northerly boundary of the Sunrise Highway
3 Service Road; thence northeastward along the northerly boundary of the
4 Sunrise Highway Service Road to Barnes Road; thence northward along the
5 westerly boundary of Barnes Road to the northeastern corner of property
6 identified as District 200, Section 750, Block 3, Lot 40.2; thence west-
7 ward along the northerly boundary of said property to the property iden-

40 ry of Forge Road (unpaved) to the intersection of Route 25 and River
41 Road; thence westward along the southerly boundary of River Road to
42 Edwards Avenue; thence northward along the westerly boundary of Edwards
43 Avenue 3,800 feet; thence westward 4,400 feet to an unnamed, unpaved
44 road; thence northward along the westerly boundary of the unnamed,
45 unpaved road 150 feet; thence westward and northwestward along the east-
46 ern boundary of the United States Navy/Grumman Aerospace Corporation
47 property (as of 1982) up to its intersection with Middle Country Road
48 (Route 25); thence westward along the southerly boundary of Route 25 to
49 the intersection of Route 25 and 25A; thence northeastward, westward,
50 and southwestward along the eastern and northern boundary of the United
51 States Navy/Grumman Aerospace Corporation (as of 1982) and located imme-
52 diately east of Route 25A, to its intersection with Route 25A; thence
53 westward along the southerly boundary of Route 25A to a point due south
54 of the southeast corner of the parcel identified as District 200,
55 Section 128, Block 1, lot 3.1; thence northward across Route 25A to its
56 northerly side at the southeast corner of parcel identified as District

30 the Central Pine Barrens area which comprise the largest intact areas of
31 undeveloped pine barrens as described and bounded as follows:

32 Beginning at a point where the northwestern corner of the New York
33 State Rocky Point Natural Resource Management Area (the "NYS Rocky Point
34 Land") intersects the southerly side of NYS Route 25A; thence generally
35 southward and eastward along the generally westerly and southerly bound-
36 aries of the NYS Rocky Point Land (including the Currans Road Pond State
37 Wildlife Management Area, all adjacent or contiguous undeveloped Town of
38 Brookhaven parks, preserves, open space areas, or reserved areas, and
39 the crossings of the undeveloped Suffolk County property known as the
40 Port Jefferson - Westhampton road right of way, Whiskey Road, County
41 Route 21, and Currans Road), and including those properties identified

13 southeast corner of the NYS Middle Island State Game Farm and Environ-
14 mental Education Center; thence northward, westward, and southward along
15 the easterly, northerly, and westerly boundaries of the NYS Middle
16 Island State Game Farm and Environmental Education Center to NYS Route
17 25; thence westward along the southerly side of NYS Route 25, excluding
18 all parcels abutting that road which are developed as of June 1, 1993,
19 to Giant Oak Road; thence southward along the easterly side of Giant Oak
20 Road to Medford Road; thence southwestward along the southeasterly side
21 of Medford Road crossing to the west side of Smith Road; thence souther-
22 ly along the westerly side of Smith Road to the southeast corner of
23 District 200, Section 406, Block 1, Lot 6; thence westward and northward
24 along the southerly and westerly sides of said parcel to the southerly
25 side of the developed lands known as Strathmore Ridge; thence westward,
26 northward and eastward along the southerly, westerly and northerly sides

16 Route 25A to its southerly boundary and the northeast corner of the
17 Shoreham-Wading river school district property, identified as District
18 200, Section 243, Block 1, Lot 3; thence southward and westward, along
19 the easterly and southerly boundaries of the aforesaid parcel to its
20 southwest corner[7]; thence southward along the easterly boundary of the
21 Shoreham-Wading River school district property identified as District
22 200, Section 243, Block 1, Lot 1.10 to its southeast corner; thence
23 westward [~~and~~], northward, eastward, southward, eastward, northward,
24 westward, northward, westward and northward in a clockwise fashion along
25 the southerly and westerly boundaries of the aforesaid Shoreham-Wading
26 River school district property to NYS Route 25A; thence westward along
27 the southerly side of NYS Route 25A to County Route 46; thence southward
28 along the easterly side of County Route 46 to its intersection with the
29 Suffolk County Pine Trail Nature Preserve; thence westward along the
30 northerly boundary of the Suffolk County Pine Trail Nature Preserve
31 where the Preserve is adjacent to developed parcels or parcels in agri-
32 cultural or horticultural use, or along a line parallel to, and 100 (one
33 hundred) feet north of, the Preserve where the Preserve is adjacent to
34 parcels which are undeveloped as of June 1, 1993, to the southeastern
35 corner of the parcel west of Woodlots Road and identified as District
36 200, Section 291, Block 1, Lot 14.1; thence northward and westward along
37 the easterly and northerly boundaries of that parcel to Whiskey Road;
38 thence westward along the southerly side of Whiskey Road to Wading River
39 Hollow Road; thence northward along the westerly side of Wading River
40 Hollow Road to the boundary of the NYS Rocky Point Land; thence general-
41 ly northward along the easterly boundary of the NYS Rocky Point Land,
42 including all adjacent or contiguous undeveloped Town of Brookhaven
43 parks, preserves, open space areas, or reserved areas, to NYS Route 25A;
44 thence westward along the southerly side of NYS Route 25A, excluding
45 those parcels abutting that road which are developed as of June 1, 1993,
46 and those lands identified for the reroute of Route 25A by the NYS
47 Department of Transportation, to the northeastern corner of the parcel
48 identified as District 200, Section 102, Block 3, Lot 1.4; thence south-
49 ward along the westerly boundary of that parcel to the parcel identified
50 as District 200, Section 102, Block 3, Lot 1.6; thence generally west-
51 ward and southward along the westerly boundaries of that parcel and the
52 adjoining southerly parcel identified as District 200, Section 102,
53 Block 3, Lot 1.5 to the boundary of the NYS Rocky Point Land; thence
54 westward along the northerly boundary of the NYS Rocky Point Land to
55 County Route 21; thence generally westward along a straight line across
56 County Route 21 to the northernmost extent along County Route 21 of the

1 NYS Rocky Point Land; thence generally westward along the generally
2 northerly boundary of the NYS Rocky Point Land to the point or place of
3 beginning, and excluding the area defined as beginning at a point where
4 the southerly boundary of NYS Route 25 meets the easterly side of the
5 Suffolk County Pine Trail Nature Preserve; thence southeastward along
6 the easterly side of the Suffolk County Pine Trail Nature Preserve where
7 the Preserve is adjacent to developed parcels, or along a line parallel
8 to, and 100 (one hundred) feet east of, the Preserve where the Preserve
9 is adjacent to parcels which are undeveloped as of June 1, 1993, to the
10 Long Island Lighting Company high voltage transmission lines; thence
11 northward along the westerly side of the Long Island Lighting Company
12 high voltage transmission lines to NYS Route 25; thence westward along
13 the southerly side of NYS Route 25 to the point or place of beginning;
14 and excluding four distinct areas described as follows: Area One is the
15 area defined as beginning at a point where the southerly boundary of NYS
16 Route 25 meets the easterly side of the Suffolk County Pine Trail Nature
17 Preserve; thence southeastward along the easterly side of the Suffolk
18 County Pine Trail Nature Preserve where the Preserve is adjacent to
19 developed parcels, or along a line parallel to, and 100 (one hundred)
20 feet east of, the Preserve where the Preserve is adjacent to parcels

22 Company high voltage transmission lines; thence northward along the

37 of the intersection of Moriches-Middle Island Road and Cranford Boule-
38 vard and thence southward along the easterly boundary of Cranford Boule-
39 vard to the southwestern corner of property identified as District 200,
40 Section 645, Block 3, Lot 29.1; thence southeastward along the southerly
41 boundary of said property to its intersection with property identified
42 as District 200, Section 712, Block 9, Lot 1; thence generally southward
43 along the westerly boundary of said property to its intersection with
44 the northerly side of the eastward extension of Grove Drive, known as
45 Grove Street; thence southward crossing Grove Street to its south side;
46 thence westward along the southerly boundary of the Grove Street road
47 extension to the northwestern corner of the property identified as
48 District 200, Section 749, Block 3, Lot 41.1 and comprised of parcels
49 owned by the county of Suffolk and the town of Brookhaven; thence south-
50 ward to the southwestern corner of property identified as District 200,
51 Section 749, Block 3, Lot 43; thence eastward along the southerly bound-
52 ary of said property to the west side of Lambert Avenue; thence crossing
53 Lambert Avenue to its easterly side; thence southward along the easterly
54 boundary of Lambert Avenue to the northerly boundary of the Sunrise
55 Highway Service Road; thence northeastward along the northerly boundary
56 of the Sunrise Highway Service Road to Barnes Road; thence northward

1 along the westerly boundary of Barnes Road to the northeastern corner of
2 the property identified as District 200, Section 750, Block 3, Lot 40.2;
3 thence westward along the northerly boundary of property identified as
4 District 200, Section 713, Block 1, Lot 2; thence westward along the
5 northerly boundary of property identified as District 200, Section 713,
6 Block 1, Lot 1; thence northward along the westerly side of Weeks Avenue
7 to the northeastern corner of property identified as District 200,
8 Section 713, Block 3, Lot 1; thence westward along the northerly bounda-
9 ry of said property to Michigan Avenue; thence northward along the east-
10 erly boundary of Michigan Avenue to Moriches-Middle Island Road; thence
11 westward along the southerly boundary of Moriches-Middle Island Road to
12 the point of beginning.

13 § 2. This act shall take effect on the same date and in the same
14 manner as a chapter of the laws of 2019 amending the environmental
15 conservation law relating to the Central Pine Barrens area and the core
16 preservation area, as proposed in legislative bills numbers S. 6357 and
17 A. 8135, takes effect; provided, however, that the amendments to subdi-
18 visions 10 and 11 of section 57-0107 of the environmental conservation
19 law made by section one of this act shall be subject to the expiration
20 of such subdivisions and shall be deemed repealed therewith.
