AN ACT to amend the real property tax law, in relation to the residential-commercial exemption program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (g) of subdivision 1 of section 485-n of the real 2 property tax law, as amended by chapter 394 of the laws of 2012, is amended to read as follows:

(g) "Municipality" means any town, city, village or other taxing entity [located in a county having a population of not less than sixty five thousand three hundred ninety and not more than sixty-five thousand four hundred as determined by the federal decennial census for the year two 8 thousand ten or in a county having a population of not less than nine-9 ty-eight thousand nine hundred and not more than ninety-nine thousand as 10 determined by the federal decennial census for the year two thousand 11 ten].

§ 2. This act shall take effect immediately, provided that the amend-12 13 ments to subdivision 1 of section 485-n of the real property tax law 14 made by section one of this act shall not affect the repeal of such 15 section and shall be deemed repealed therewith.
