AN ACT to amend the tax law, in relation to the taxable price for the sale of a motor vehicle

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 1105 of the tax law is amended by adding a new subdivision (g) to read as follows: <u>(g) Any rebate offered by a retail dealer of a motor vehicle to a</u>

4 <u>consumer at the time of sale shall be excluded for the purposes of</u> 5 <u>calculating the taxable price under this section of such motor vehicle</u> 6 <u>sale. Such rebate shall further be excluded for the purposes of calcu-</u> 7 <u>lating any local sales and compensating use tax that may be applicable.</u>

8 § 2. This act shall take effect on the thirtieth day after it shall 9 have become a law.
