AN ACT to amend the environmental conservation law, in relation to prohibiting the sale of child care products containing bisphenol

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The title heading of title 5 of article 37 of the environ-1 2 mental conservation law, as added by chapter 280 of the laws of 2010, is 3 amended to read as follows: 4 BISPHENOL [A] 5 § 2. Short title. 8 This title shall be known and may be cited as the "bisphenol $[\frac{A-free}{P}]$ **free** children and babies act". 9 § 3. Section 37-0505 of the environmental conservation law, as added 10 by chapter 280 of the laws of 2010, is amended to read as follows: 11 § 37-0505. Child care products. 12 1. (a) Beginning December first, two thousand ten, no person, firm, 13 14 partnership, association, limited liability company or corporation shall 15 sell or offer for sale any child care product intended for use by a child three years of age or younger containing bisphenol A. 16 17 (b) Beginning December thirty-first, two thousand twenty-one, no person, firm, partnership, association, limited liability company or 18 corporation shall sell or offer for sale any child care product intended 19 20 for use by a child three years of age or younger containing bisphenol AF 21 (BPAF), bisphenol Z (BPZ), bisphenol S (BPS), bisphenol F (BPF), bisphe-22 nol AP (BPAP) and bisphenol B (BPB). 2. The provisions of this section shall not apply to the sale or 23 24 distribution of child care products resold or offered for resale, or

25 distributed by consumers for consumer use.

Section 37-0509 of the environmental conservation law, as added 9 by chapter 280 of the laws of 2010, is amended to read as follows: § 37-0509. Preemption. 10 Jurisdiction in all matters pertaining to bisphenol [A] which are 11 12 regulated pursuant to the provisions of this title shall be vested 13 exclusively in the state.
