- AN ACT to amend the environmental conservation law, in relation to polystyrene waste reduction

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Article 27 of the environmental conservation law is 2 amended by adding a new title 30 to read as follows:

10 11	§ 27-3001. Definitions. For the purposes of this title, the following terms shall have the
12	following meanings:
13	1. "Affordable" means purchasable for not more than fifteen percent
14	more than the purchase cost of the non-compostable or non-recyclable
15	alternative.
16	2. "Agency" means any state department, agency, board, public benefit
17	corporation, public authority, or commission.

"Compostable" means all the materials in the product or package 1 3. meet the American Society for Testing and Materials (ASTM) International 2 3 Standard Specification for Compostable Plastics D6400, and will: (a) 4 undergo degradation by biological processes during composting in an 5 appropriate municipal or industrial composting facility to yield carbon б dioxide, water, inorganic compounds, and biomass at a rate consistent with other known compostable materials in similar facilities; and (b) 7 leave no visible, distinguishable or toxic residue, including no adverse 8 9 impact on the ability of composts to support plant growth once the 10 finished compost is placed in soil. 11 4. "Contractors and lessees" mean any person or entity that has a contract with an agency or a municipality for public works or improve-12 13 ments to be performed, for a franchise, concession or lease of property, 14 for grant monies or goods and services or supplies to be purchased at the expense of the agency or municipality or to be paid out of monies 15 16 deposited in the treasury or out of trust monies under the control or 17 collected by the agency or municipality. 5. "Disposable food service container" means all containers, bowls, 18 19 plates, trays, cartons, cups, lids and other items that are designed or 20 generally recognized by the public as being designed for one-time use to 21 hold, contain, or transport foods, including without limitation, containers for takeout foods and/or leftovers from partially consumed 22 meals prepared by retail food vendors. For the purpose of this title, 23 the term "disposable food service container" does not include containers 24 or other items that are used for the transportation, storage, or display 25 26 of raw eqgs, or raw or uncooked butchered meats, fish, seafood, and/or 27 poultry sold from a butcher case or similar retail appliance. 28 6. "Home compostable" means all the materials in the product or pack-29 age conform with the Vincotte OK Compost Home certification using the European Norm 13432 standard, or a comparable standard as determined by 30 31 the department, and will: (a) undergo degradation by biological proc-32 esses during composting in a home compost pile or device to yield carbon 33 dioxide, water, inorganic compounds, and biomass at a rate consistent with other known compostable materials in similar facilities; and (b) 34 35 leave no visible, distinguishable or toxic residue, including no adverse 36 impact on the ability of composts to support plant growth once the 37 finished compost is placed in soil. 38 7. "Municipality" means a village, town, city, or county, or any 39 designated agency thereof. 40 8. "Polystyrene foam" means blown polystyrene and expanded and extruded foams that are thermoplastic petrochemical materials utilizing a 41 42 styrene monomer and processed by any number of techniques including, but 43 not limited to, fusion of polymer spheres, injection molding, foam molding, and extrusion-blown molding. Polystyrene foam is generally used to 44 45 make cups, bowls, plates, trays, clamshell containers, meat trays and 46 egg cartons. Such term shall not include rigid polystyrene. 47 9. "Recyclable" means material that can be sorted, cleansed and reconstituted using available recycling collection programs for the purpose 48 49 of using the altered form in the manufacture of a new product. Recycling does not include burning, incinerating, converting, or otherwise ther-50 51 mally destroying solid waste. 52 <u>§ 27-3003. Prohibited disposable food service containers.</u> 53 1. Agencies, municipalities, and their contractors and lessees shall 54 not purchase, acquire, possess, sell, use, or offer for use disposable

16	<u>Any agency or municipality may promulgate regulations, ordinances, or</u>
17	laws to take any and all reasonable actions necessary to implement and
18	enforce this title.
19	§ 2. The department of environmental conservation shall conduct a
20	study on the desirability, feasibility and environmental impact of a
21	statewide prohibition on the use of disposable food service containers
22	that contain polystyrene foam. The department shall issue a report
23	containing the results of the study to the legislature no later than the
24	thirty-first of January next succeeding the date on which this act shall
25	have become a law.
