AN ACT to amend the education law, in relation to requiring postsecondary institutions that participate in study abroad programs to report crime and harm that occurs to participating students

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Short title. This act shall be known and may be cited as 2 the "Safe Student Study Abroad Act" also known as the "Ravi Thackurdeen Safe Student Study Abroad Act".

§ 2. The education law is amended by adding a new article 130-A to 5 read as follows:

- § 6457. Definitions. As used in this article, the following terms 14 shall have the following meanings:
- 1. "College", "university" and "postsecondary" shall mean any institu-15 tion of higher education, recognized and approved by the regents, which 16 17 provides a course of study leading to the granting of a postsecondary 18 <u>degree or diploma.</u>
- 19 2. "Third party entities" shall mean any for profit or not-for-profit 20 <u>business</u> that is not a college, university or postsecondary institution 21 which provides a study abroad program or coordinates a program between 22 college, university or postsecondary institution in the United States 23 and a study abroad program.

"Study abroad program" shall mean programs which are coordinated by 2 college, university or postsecondary institutions and third party enti-3 ties in the state of New York, that provide students with the opportunity to work or study, wholly or in principal part, outside of the United States of America.

- 4. "Study abroad organization" shall mean college, university or postsecondary institutions as well as third party entities that offer study abroad programs.
- § 6458. General provisions. Study abroad organizations shall prioritize the health, safety, and security of its students through policies, 11 procedures, advising, orientation, and training.
  - 1. Study abroad organizations shall prioritize health, safety, and security in program development, implementation and management by conducting appropriate risk assessments for such program sites and activities, maintaining written emergency plans and protocols, and identifying and leveraging relevant authorities, networks and resources.
  - 2. Study abroad organizations' staff shall be trained to anticipate and respond responsibly to student health, safety, or security issues and students shall be provided training to responsibly manage their own health, safety, and security while abroad. Study abroad organizations shall establish measures to monitor and advise students on health, safety, and security issues through the United States department of state and other appropriate resources.
  - 3. Study abroad organizations shall maintain appropriate insurance policies at recommended levels, operate in compliance with local laws, and follow best practices in reporting on critical incidents.
  - 4. Study abroad organizations may adopt and implement policies in accordance with the Standards of Good Practice for Education Abroad, made available by the Forum on Education Abroad.
  - § 6459. Reporting. 1. Beginning one year after the effective date of this article, study abroad organizations shall make and file an annual report to the department by August fifteenth of each year. Such report shall be prepared by all reasonably available data and shall consist of data from the previous two years and comply with the federal health insurance portability and accountability act (HIPAA) of 1996, as amended, Title IX of the Education Amendments of 1972 (20 U.S.C. section 1681, et. seq.) and all other applicable regulations. Data representing individuals shall be in numerical form omitting personal information.
    - 2. The report mandated by this section shall include:
- a. for the previous academic year, including summer terms, the effec-40 41 tiveness of the study abroad program at protecting students from crime 42 and harm, whether changes to such program are needed and how such chang-43 es will be implemented;
- 44 b. for the ten years preceding the date of the report, when such data 45 is reasonably attainable, the number of:
  - i. deaths of program participants including manner of death;
- ii. accidents and illnesses that resulted in hospitalization including 47 48 the type of such accident or illness;
  - iii. sexual assaults against program participants;
- iv. incidents that resulted in a police report including type of inci-50 51 dent; and
- v. with respect to the incidents described in subparagraphs i through 52 53 iv of this paragraph, whether the incidents occurred:
  - (1) during program participation;
- 55 (2) during students own time;
- 56 (3) on campus;

- (5) the location of the incident; and
  - (6) the time of the incident.
- 4 c. Study abroad organizations shall also report on ethical relation-5 ships and conflict of interest avoidance policies with all major part-6 ners.
  - § 6460. Student resources. 1. Study abroad organizations shall provide each student who is interested in participating in a program of study abroad, with pre-registration information advising that includes:
- a. all current travel information, including all travel warnings and travel alerts, issued by the bureau of consular affairs of the department of state for such countries;
- b. all current safety alerts known within thirty miles of the campus including information obtained by students from post-trip orientation sessions or reports; and
- 16 <u>c. the reporting information required by the department as identified</u> 17 <u>in section sixty-four hundred fifty-nine of this article.</u>
- 2. Study abroad organizations shall provide each student who returns from a study abroad program with an anonymous post-semester evaluation questionnaire, and the opportunity for a documented exit interview which shall focus on the program's effectiveness in best practices and student safety. These reports are to be made available to the public upon request.
- 3. Study abroad organizations shall include references to the availability of the reports identified in section sixty-four hundred fiftynine of this article and this section on all websites and printed materials.
- § 6461. Program assessment. The department shall, using existing staff 28 29 and budget, assess the effectiveness of this article and appropriate state regulation of postsecondary study abroad programs. The assessment 30 31 shall focus on the protection, the health and safety of students in 32 postsecondary study abroad programs; and the reporting process. The department shall make their assessments and the reports required in 33 section sixty-four hundred fifty-nine of this article to any state 34 35 <u>legislator upon request.</u>
  - § 3. This act shall take effect immediately.
