Introduced by Sen. GOUNARDES -- read twice and ordered printed, and when printed to be committed to the Committee on Elections -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the election law, in relation to provision of interpreters at poll sites in certain cities

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The election law is amended by adding a new section 8-110  
2 to read as follows:

3 § 8-110. Board of elections; provision of interpreters. 1. Notwith-  
4 standing any provision of law to the contrary, any board of elections in  
5 a city with a population of one million or more shall, at a minimum,  
6 provide interpreters for all languages that are designated city-wide  
7 languages pursuant to section 23-1101 of the administrative code of the  
8 city of New York or other applicable statute at all poll sites that  
9 contain an election district with at least fifty voting age residents  
10 whose limited English proficiency language is a designated city-wide  
11 language. The voting districts with at least fifty voting age residents  
12 with limited English proficiency shall be made by the board of elections  
13 based upon the most recent United States census data or American commu-  
14 nity service data, whichever is more recent, and beginning on January  
15 first, two thousand twenty-two, such data shall be reviewed every two  
16 years. Unless an election district has at least fifty voting age resi-  
17 dents with limited English proficiency who speak a specific city-wide  
18 language, an interpreter for such city-wide language shall not be  
19 required for any poll site in such election district.

20 2. All interpreters provided by a board of elections pursuant to  
21 subdivision one of this section shall be made available to the public  
22 inside the poll site. Any interpreter who engages in any activity in

1 violation of subdivision one of section 8-104 of this article shall be  
2 immediately relieved of his or her duties as an interpreter.

3 3. Nothing in this section shall restrict or prohibit a board of  
4 elections from providing interpreters for languages that are not  
5 required pursuant to this section.

6 4. The state board of elections shall promulgate rules and regulations  
7 that include establishing standards for the number of interpreters that  
8 will be required at each poll site based upon the number of voting age  
9 residents in an election district with limited English proficiency that  
10 speak a specific language.

11 § 2. This act shall take effect on the first of January next succeed-  
12 ing the date on which it shall have become a law. Effective immediately,  
13 the addition, amendment and/or repeal of any rule or regulation neces-  
14 sary for the implementation of this act on its effective date are  
15 authorized to be made and completed on or before such effective date.
