AN ACT to amend the correction law, in relation to establishing a program for elderly inmates who are under community supervision or who will be released from a state correctional facility

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The correction law is amended by adding a new section 210 to read as follows:

- § 210. Reentry for the elderly program. 1. The department shall establish a reentry for the elderly program using existing funds for adults over fifty years of age who are under community supervision or who will be released from a state correctional facility.

The commissioner, in consultation with the office of minority health, the commissioner of the city of New York department of health 8 9 and mental hygiene, the commissioner of the city of New York department 10 of homeless services and the commissioner of the city of New York department of social services and local stakeholders such as senior 11 centers and service providers, shall be responsible for the implementa-12 tion and coordination of program services provided for in this section 13 for participants who are on community supervision or will be released
- 14 15 from a state correctional facility to the city of New York.
- 16 3. The commissioner, in consultation with county departments of 17 health, mental health and social services, and with local stakeholders

- will be released from a state correctional facility to a county outside the city of New York.
- 3 4. The program shall include, but not be limited to, the following components:
- (a) geriatric assessment and discharge planning to assess individual needs and develop individualized release plans;
- (b) parole board interview preparation including identification of 7 8 approved residences; and
- 9 (c) case management to connect participants to appropriate housing, 10 medical and behavioral health care, benefits, employment, and services 11 available through senior centers, and provide ongoing support.
- 5. The commissioners of the city of New York departments of health and 13 mental hygiene, homeless services and social services and county commissioners of health, mental health, and social services shall cooperate with the commissioner, as well as the office of minority health, in furtherance of the program provided for in this section.
- 17 6. The department may, subject to available appropriations, contract with a non-profit entity for the performance of the functions set forth 18 in this section. 19
- 20 § 2. This act shall take effect on the one hundred eightieth day after 21 it shall have become a law.
