AN ACT to amend the general obligations law, in relation to independent consideration required for certain provisions in settlement agreements and violations of nondisclosure agreements in certain settlement agreements

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The general obligations law is amended by adding a new 2 section 5-1117 to read as follows:

§ 5-1117. Independent consideration required for settlement agree-4 ments. Independent consideration shall be required for each confidentiality provision included in a settlement agreement. For the purposes of this section, "independent consideration" shall mean something of value, either a promise, an act or an object that is offered in exchange for each confidentiality provision.

- § 2. Section 5-336 of the general obligations law, as added by section 10 1 of subpart D of part KK of chapter 57 of the laws of 2018, is amended to read as follows:
- 11 § 5-336. Nondisclosure agreements. (a) Notwithstanding any other law 12 13 to the contrary, no employer, its officers or employees shall have the authority to include or agree to include in any settlement, agreement or other resolution of any claim, the factual foundation for which involves 15 sexual harassment, any term or condition that would prevent the disclo-16 sure of the underlying facts and circumstances to the claim or action 17 18 unless the condition of confidentiality is the complainant's preference. 19 Any such term or condition must be provided to all parties, and the 20 complainant shall have twenty-one days to consider such term or condiafter twenty-one days such term or condition is the 21
- 22 complainant's preference, such preference shall be memorialized in an 23 agreement signed by all parties. For a period of at least seven days

following the execution of such agreement, the complainant may revoke the agreement, and the agreement shall not become effective or be 3 enforceable until such revocation period has expired.

- (b) Notwithstanding any other law to the contrary, no person shall have the authority to include or agree to include in any settlement, agreement or other resolution of any claim, the factual foundation for which involves sexual harassment or any other form of discrimination prohibited by law, any term or condition that requires the complainant to pay the defendant liquidated damages in the event that the plaintiff violates a nondisclosure agreement included in such settlement, agree-10 11 ment, or other resolution of a claim.
- 12 § 3. This act shall take effect immediately.
