AN ACT authorizing the city of Albany to alienate certain lands used as parkland and to dedicate certain other lands as parklands

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act, the city of Albany,
2 Albany county, acting by and through its governing body, is hereby
3 authorized to discontinue the use of parklands and alienate such lands
4 more particularly described in section three of this act, for the
5 purpose of constructing and maintaining a new underground pipe through
6 Lincoln Park in connection with the disinfection and floatables control
7 project, and associated infrastructure, also known as the Beaver Creek
8 Clean River Project (screening and disinfection satellite treatment
9 facility), within such parklands, and upon such other terms and condi-
10 tions as determined by the governing body of the city of Albany.

11 § 2. The authorization contained in section one of this act shall take
12 effect only upon the condition that the city of Albany shall dedicate an
13 amount equal to or greater than the fair market value of the parklands
14 being discontinued towards the acquisition of new parklands and/or capi-
15 tal improvements to existing park and recreational facilities.

16 § 3. The parklands authorized by section one of this act to be discon-
17 tinued as parklands are described as follows:

18 All that tract or parcel of land situate in the City of Albany, County
19 of Albany, and State of New York more particularly bounded and described
20 as follows:

21 Parcel 1A-2019

22 Commencing at a point on the westerly street boundary of Martin Luther
23 King Jr. Boulevard at its intersection with the southerly street bounda-
24 ry of Park Avenue and running along the said westerly street boundary of
25 Martin Luther King Jr. Boulevard a distance of 235± feet to the point of

1 beginning of Parkland Alienation Parcel 1-2018; thence continuing along
2 said westerly street boundary of Martin Luther King Jr. Boulevard the
3 following two (2) courses and distances:

4 1. South 24°31'32" West, a distance of 9.53 feet to a point of curva-
5 ture; and

6 2. along a curve to the left having a radius of 308.00 feet, an arc
7 length of 47.87 feet and a chord of South 20°04' 22" West, a distance of
8 47.82 feet to a point;

9 thence running through lands now or formerly of the City of Albany,

41 ing along said northerly street boundary of Morton Avenue, a distance of
42 50.00 feet; thence turning and running through lands now or formerly of
43 the City of Albany, Tax Parcel 76.10-1-3 from said Point of Beginning
44 the following four (4) courses and distances:

46 2. North 50°48'41" West, a distance of 273.01 feet to a point; thence

53 2. South 12°18'59" West, a distance of 50.52 feet to a point; and

54 3. South 15°50'09" West, a distance of 25.93 feet to a point; thence

55 turning and running through lands now or formerly of the City of Albany,
56 Tax Parcel 76.10-1-3 the following four (4) courses and distances:

1 1. South 16°26'04" East, a distance of 98.46 feet to a point; thence
2 2. South 16°26'04" East, a distance of 407.29 feet to a point;
3 3. South 50°48'41" East, a distance of 253.58 feet to a point; and
4 4. South 19°00'12" West, a distance of 42.78 feet to the point of
5 beginning.

6 Both parcels containing a total of 1.29 acres of land more or less.

7 § 4. In the event that the city of Albany received any funding support
8 or assistance from the federal government for the purchase, maintenance
9 or improvement of the parklands set forth in section three of this act,
10 the discontinuance and alienation of such parkland authorized by the
11 provisions of this act shall not occur until the city of Albany has
12 complied with any federal requirements pertaining to the alienation or
13 conversion of such parklands, including satisfying the secretary of the
14 interior that the alienation or conversion complies with all conditions
15 which the secretary of the interior deems necessary to assure the
16 substitution of other lands shall be equivalent in fair market value and
17 usefulness to the lands being alienated or converted.

18 § 5. This act shall take effect immediately.
