AN ACT to amend the social services law, in relation to home visiting services for applicants for, or recipients of, public assistance benefits who are exempt from certain work activities

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

## 1 Section 1. Section 332 of the social services law is amended by adding 2 a new subdivision 1-a to read as follows:

1-a. Applicants for, or recipients of, public assistance who are 3 4 exempt from work activities pursuant to paragraph (d) or (e) of subdivision one of this section shall be eligible to receive home visiting 5 services that meet the criteria established pursuant to 42 U.S.C. 711, б 7 so long as such individual meets all other eligibility criteria estab-8 lished pursuant to the particular home visiting model. The local social 9 services district shall provide information to any applicant or recipi-10 ent that is interested in receiving such services and provide assistance in determining the most appropriate model to meet the particular needs 11 12 of the individual.

13 § 2. Subdivision 1 of section 335 of the social services law, as 14 amended by chapter 214 of the laws of 1998, is amended and a new para-15 graph (c) is added to subdivision 2 to read as follows:

16 1. Each social services official shall ensure that each recipient of 17 public assistance who is a member of a household with dependent children 18 and is eighteen years of age or older, or who is sixteen or seventeen 19 years of age and is not attending secondary school and has not completed 20 high school or a high school equivalency program, receives an assessment 21 of employability based on his or her educational level, including liter-22 acy and English language proficiency, basic skills proficiency, child 23 care and other supportive services needs; and skills, prior work experi-24 ence, training and vocational interests. This assessment shall include a

1 review of family circumstances including a review of any special needs 2 of a child <u>and whether home visiting services would be appropriate and</u> 3 <u>beneficial for the family</u>. Such assessment shall be completed within 4 ninety days of the date on which such person is determined eligible for 5 public assistance. An applicant for or recipient of public assistance 6 may be assigned to work activities prior to completion of such assess-7 ment.

8 (c) Where an assessment indicates that home visiting services would be 9 appropriate and beneficial to the public assistance household, and such 10 services are available, the local social services official shall encourage the recipient to participate in such services. To the extent that 11 such participant is interested in receiving home visiting services, the 12 13 local social services official shall assign the participant to a work 14 activity in accordance with paragraph (f) or (m) of subdivision one of section three hundred thirty-six of this title, where such home visiting 15 16 services shall count towards the individual's work requirements as set 17 forth in section three hundred thirty-five-b of this title.

18 § 3. Paragraph (c) of subdivision 5 of section 335-b of the social 19 services law, as added by section 148 of part B of chapter 436 of the 20 laws of 1997, is amended to read as follows:

21 (c) Each social services official shall ensure that each parent or caretaker of a child, when such parent or caretaker is receiving public 22 assistance, is engaged in work as soon as practicable. Provided, howev-23 er, that such social services official shall ensure that each parent or 24 25 caretaker of a child under the age of five is provided with information 26 regarding home visiting programs which meet the criteria established 27 pursuant to 42 U.S.C. 711 in their area, and that such home visiting 28 services may satisfy a portion of such individual's required work activ-29 ities.

30 § 4. Paragraphs (f) and (m) of subdivision 1 of section 336 of the 31 social services law, paragraph (f) as amended by chapter 275 of the laws 32 of 2017, and paragraph (m) as amended by section 148 of part B of chap-33 ter 436 of the laws of 1997, are amended to read as follows:

34 (f) job search and job readiness assistance, which shall include 35 activities with the goal of seeking or obtaining employment, or preparation to seek or obtain employment, including life-skills training, which 36 shall include but not be limited to home visiting services to the recip-37 ient and their family, and provided further that job search is an active 38 and continuing effort to secure employment configured by the local 39 social services official; and such social services district may work in 40 41 cooperation with the department of labor to provide workforce quidance 42 and information in accordance with section ten-c of the labor law; 43 (m) job search and job readiness assistance, as defined in paragraph (f) of this subdivision, once the individual has exceeded the six week 44
