AN ACT to amend the alcoholic beverage control law, in relation to a license to sell liquor at retail for consumption on certain premises

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 7 of section 64 of the alcoholic beverage 2 control law is amended by adding a new paragraph (e-11) to read as 3 follows:

(e-11) Notwithstanding the provisions of paragraph (a) of this subdi-5 vision, the authority may issue a retail license for on-premises 6 consumption for a premises which shall be located within two hundred feet of a building occupied as a church, synagogue or other place of worship, provided such premises constitute a premises for the sale of food or beverages at retail for consumption on the premises located wholly within the boundaries of the borough of Manhattan in the city and 11 county of New York, bounded and described as follows:

All that certain tract, piece or parcel of land situate in the City of 12 13 New York, Borough of Manhattan, County of New York, State of New York, 14 known as Paramount Plaza as represented on a map entitled "EXISTING 15 BUILDING FOOTPRINT" dated January 2, 2019 as prepared by Maser Consulting and being more particularly bounded and described as follows: 16
