AN ACT to amend the public health law, in relation to the disclosure, testing and reporting of vapor products

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Section 1399-aa of the public health law is amended by 2 adding a new subdivision 14 to read as follows:
- 14. "Vapor product" means any non-combustible liquid or gel, regardless of the presence of nicotine therein, that is manufactured in to a finished product for use in an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, vaping pen, hookah pen, or other similar device.
- 8 § 2. The public health law is amended by adding a new section 9 1399-mm-1 to read as follows:
- 10 § 1399-mm-1. Disclosure, testing and reporting; electronic cigarette
  11 and vapor product. 1. On and after the effective date of this section,
  12 each electronic cigarette or vapor product manufacturer or importer, or
  13 agents thereof, shall submit to the department the following informa14 tion:
- 15 <u>(a) a listing of all ingredients, including substances, compounds, and</u>
  16 <u>additives that are, as of such date, added by the manufacturer to a</u>
  17 <u>vapor product;</u>
- 18 <u>(b) a description of the content, delivery, and form of nicotine in</u>
  19 <u>each vapor product measured in milligrams of nicotine in accordance with</u>
  20 regulations promulgated by the department; and
- 21 (c) a listing of all constituents, including smoke constituents as 22 applicable, identified by the department as harmful or potentially harm-
- 23 ful to health in each vapor product by brand and by quantity in each
- 24 brand and sub-brand. The manufacturer, importer, or agent shall comply
- 25 with regulations promulgated under this section, where applicable.

- 2. The department shall have the authority to conduct or to require
  the testing, reporting, or disclosure of vapor product constituents,
  including smoke constituents.
- § 3. The department of health shall promulgate any necessary rules and regulations, including, but not limited to, requiring the testing and reporting of vapor product constituents, ingredients, and additives, including vapor constituents, by brand and sub-brand that the department determines should be tested to protect the public health.
- 9 § 4. This act shall take effect on the one hundred twentieth day after 10 it shall have become a law.
