AN ACT to amend the retirement and social security law, in relation to establishing a twenty year retirement plan for members or officers of law enforcement

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The retirement and social security law is amended by adding  
2 a new section 383-e to read as follows:

3 § 383-e. Retirement of officers of state law enforcement; twenty year  
4 retirement plan. a. Membership. Every non-seasonally appointed sworn  
5 member or officer of the division of law enforcement in the department  
6 of environmental conservation, a forest ranger in the service of the  
7 department of environmental conservation, which shall mean a person who  
8 serves on a full-time basis in the title of forest ranger I, forest  
9 ranger II, forest ranger III, assistant superintendent of forest fire  
10 control, superintendent of forest fire control or any successor titles  
11 or new titles in the forest ranger title series in the department of  
12 environmental conservation, a police officer in the department of envi-  
13 ronmental conservation, the regional state park police, and university  
14 police officers who enter or re-enter service in any such title shall be  
15 covered by the provisions of this section, and every member described in  
16 this subdivision in such service on or before one year prior to the  
17 effective date of this section may elect to be covered by the provisions  
18 of this section by filing an election therefor with the comptroller. To  
19 be effective, such election must be duly executed and acknowledged on a  
20 form prepared by the comptroller for that purpose.

21 b. Retirement allowance. A member, covered by the provisions of this  
22 section at the time of retirement, shall be entitled to retire upon  
23 completion of twenty years of total creditable service in such titles,  
24 and shall retire upon the attainment of the mandatory retirement age  
25 prescribed by this section, by filing an application therefor in a  
26 manner similar to that provided in section three hundred seventy of this  
27 article.

1 1. Upon completion of twenty years of such service and upon retire-  
2 ment, each such member shall receive a pension which, together with an  
3 annuity for such years of service as provided in paragraph four of this  
4 subdivision, shall be sufficient to provide him or her with a retirement  
5 allowance of one-half of his or her final average salary.

6 2. Upon completion of more than twenty years of such service and upon  
7 retirement, each such member shall receive, for each year of service in  
8 excess of twenty, an additional pension which, together with an annuity  
9 for each such year as provided in paragraph four of this subdivision,  
10 shall be equal to one-sixtieth of his or her final average salary,  
11 provided, however, that the pension payable pursuant to this section  
12 shall be subject to the provisions of section four hundred forty-four of  
13 this chapter.

14 3. Upon attainment of the mandatory retirement age without completion  
15 of twenty years of such service, each such member shall receive a  
16 pension which, together with an annuity for such years of service as  
17 provided in paragraph four of this subdivision, shall be equal to one-  
18 fortieth of his or her final average salary for each year of creditable  
19 service in such titles. Every such member shall also be entitled to an  
20 additional pension equal to the pension for any creditable service  
21 rendered while not an employee in such titles as provided under para-  
22 graphs three and four of subdivision a of section three hundred seven-  
23 ty-five of this article. This latter pension shall not increase the  
24 total allowance to more than one-half of his or her final average sala-  
25 ry.

26 4. The annuity provided under paragraphs one, two and three of this  
27 subdivision shall be the actuarial equivalent, at the time of retire-  
28 ment, of the member's accumulated contributions based upon the rate of  
29 contribution fixed under section three hundred eighty-three of this  
30 title and upon the salaries earned while in such service. Such annuity  
31 shall be computed as it would be if it were not reduced by reason of the  
32 member's election to decrease his or her contributions toward retirement  
33 in order to apply the resulting amount toward payment of contributions  
34 for old age and survivor's insurance. Any accumulated contributions in  
35 excess of the amount required to provide the annuity computed pursuant  
36 to this paragraph shall be used to increase the member's retirement  
37 allowance.

38 c. Credit for previous service. In computing the years of total cred-  
39 itable service for each member described herein, full credit shall be  
40 given and full allowance shall be made for service rendered as a police  
41 officer or state university peace officer or member of a police force or  
42 department of a state park authority or commission or an organized  
43 police force or department of a county, city, town, village, police  
44 district, authority or other participating employer or member of the  
45 capital police force in the office of general services while a member of  
46 the New York state and local police and fire retirement system, of the  
47 New York state and local employees' retirement system or of the New York  
48 city police pension fund and for all service for which full credit has  
49 been given and full allowance made pursuant to the provisions of section  
50 three hundred seventy-five-h of this article provided, however, that  
51 full credit pursuant to the provisions of such section shall mean only  
52 such service as would be creditable service pursuant to the provisions  
53 of section three hundred eighty-three, three hundred eighty-three-a,  
54 three hundred eighty-three-b, as added by chapter six hundred seventy-  
55 four of the laws of nineteen hundred eighty-six, three hundred eighty-  
56 three-b, as added by chapter six hundred seventy-seven of the laws of

1 nineteen hundred eighty-six, three hundred eighty-three-c or three  
2 hundred eighty-three-d of this title or pursuant to the provisions of  
3 title thirteen of the administrative code of the city of New York for  
4 any member contributing pursuant to this section who transferred to the  
5 jurisdiction of the department of environmental conservation including  
6 but not limited to environmental conservation officers and forest  
7 rangers, regional state park police or state university of New York  
8 peace officers.

9 d. Retirement for cause. Upon receipt of a certificate from the head  
10 of the entity where such member is employed or his or her designee, a  
11 member as described in subdivision a of this section, who has accrued  
12 twenty-five or more years of service credit under this section shall be  
13 retired on the first day of the second month next succeeding the date  
14 such certificate was filed with the comptroller.

15 e. Credit for military service. In computing the years of total cred-  
16 itable service full credit shall be given and full allowance shall be  
17 made for service of such member in war after world war I as defined in  
18 section three hundred two of this article, provided such member at the  
19 time of his or her entrance into the armed forces was in police service  
20 as defined in subdivision eleven of section three hundred two of this  
21 article.

22 f. Transfer of membership to employees' retirement system. Any member  
23 currently enrolled pursuant to this section and who previously trans-  
24 ferred service credit from the New York state and local employees'  
25 retirement system to the New York state and local police and fire  
26 retirement system, may elect to transfer such previously transferred  
27 service credit back to the New York state and local employees' retire-  
28 ment system, and such member shall have the option to retroactively  
29 transfer his or her membership into such employees' retirement system.

30 g. The provisions of this section shall be controlling, notwithstand-  
31 ing any provision of this article to the contrary.

32 § 2. All past service costs associated with implementing the  
33 provisions of this act shall be borne by the state of New York and may  
34 be amortized over a period of ten years.

35 § 3. This act shall take effect on the sixtieth day after it shall  
36 have become a law.

FISCAL NOTE.--Pursuant to Legislative Law, Section 50:

This bill will allow any non-seasonally appointed sworn member or officer of the division of law enforcement, police officer, or forest ranger in the department of environmental conservation; a regional state park police officer; or a university police officer to become covered by the provisions of a special 20-year retirement plan, which will provide a benefit of one-half of final average salary upon retirement, and an additional benefit of one-sixtieth of final average salary for each year of creditable service in excess of 20 years, not to exceed 12 such years.

If this bill is enacted, there will be an increase in the annual contributions of the state of New York of approximately \$3.3 million for the fiscal year ending March 31, 2021.

In addition to the annual contributions discussed above, there will be an immediate past service cost to the state of New York of approximately \$39.4 million. This estimate is based on the assumption that payment will be made on March 1, 2021. If the State of New York elects to amortize this cost over a 10-year period, the cost for the first year would be \$5.2 million.

This estimate is based on 1,207 affected officers, with an estimated annual salary of approximately \$99 million for the fiscal year ending March 31, 2019.

Summary of relevant resources:

The membership data used in measuring the impact of the proposed change was the same as that used in the March 31, 2019 actuarial valuation. Distributions and other statistics can be found in the 2019 Report of the Actuary and the 2019 Comprehensive Annual Financial Report.

The actuarial assumptions and methods used are described in the 2015, 2016, 2017, 2018 and 2019 Annual Report to the Comptroller on Actuarial Assumptions, and the Codes, Rules and Regulations of the State of New York: Audit and Control.

The Market Assets and GASB Disclosures are found in the March 31, 2019 New York State and Local Retirement System Financial Statements and Supplementary Information.
