The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 2	Section 1. Section 44 of the banking law is amended by adding a new subdivision 10 to read as follows:

13	institution fund established pursuant to subdivision three of section
14	sixteen-o of the New York state urban development corporation act.
15	§ 3. This act shall take effect September 1, 2022.
