AN ACT to amend the penal law, in relation to hate crimes

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 3 of section 485.05 of the penal law, as  
2 amended by section 3 of part R of chapter 55 of the laws of 2020, is  
3 amended to read as follows:

4 3. A "specified offense" is an offense defined by any of the following

38 § 2. This act shall take effect on the first of November next succeed-  
39 ing the date on which it shall have become a law.
