AN ACT to amend the executive law and the general municipal law, in relation to requiring the division of state police and local police departments to notify a licensed child day care center or group day care home in the area of certain emergency situations

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1	Section 1. The executive law is amended by adding a new section 235 to

4	police shall notify every child day care provider, child day care

9	shooter incidents occurring in the vicinity of such child day care
10	center or group day care home. Such notice shall be given by a telephone
11	call made to a designated individual at each child day care provider,
12	child day care center, group family day care home, family day care home,
13	and school aged child care home within thirty minutes of the occurrence
14	of the emergency situation. Each child day care provider, child day care
15	center, group family day care home, family day care home, and school
16	aged child care home shall provide the local department of the division
17	of state police with the name and contact information for the person it
18	has selected as the designated person to receive notice of such emergen-

20	§ 2. The general municipal law is amended by adding a new section
