AN ACT to amend the real property tax law, in relation to imposing an additional tax on certain non-primary residence class one and class two properties in a city with a population of one million or more

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The real property tax law is amended by adding a new 1 2 section 307-b to read as follows: 3 § 307-b. Additional tax on certain non-primary residence properties in 4 a city with a population of one million or more. 1. Generally. Notwith-5 standing any provision of any general, specific or local law to the 6 contrary, any city with a population of one million or more is hereby authorized and empowered to adopt and amend local laws in accordance 7 8 with this section imposing an additional tax on certain residential 9 properties and dwelling units. 10 2. Definitions. As used in this section: (a) "Assessed value" means

10 2. Definitions. As used in this section: (a) "Assessed value" means 11 the determination made by the assessors of a city having a population of 12 one million or more of the valuation of real property.

13 (b) "Assessed value attributable to a tenant-stockholder" means the 14 proportion of the assessed value of real property owned by a cooperative 15 apartment corporation, represented by a tenant-stockholder's share or 16 shares of stock in such corporation as determined by its or their 17 proportional relationship to the total outstanding stock of the corpo-

18 ration, including that owned by the corporation.

(c) "Commissioner of finance" means the commissioner of finance of a city having a population of one million or more, or his or her designee.
(d) "Department of finance" means the department of finance of a city having a population of one million or more.
(e) "Five-year average market value" shall mean the average monetary value of a property for the previous five years, using a comparable sale-based valuation method, as determined by the department of finance.
3. Additional tax. (a) A local law enacted pursuant to this section may provide for a tax as follows for fiscal years beginning on or after July first, two thousand twenty-two:
(i) For one, two or three family residences with a five-year average market value of five million dollars or higher, a tax of at least one-

13 half percent and no more than four percent on the excess market value 14 above five million dollars. (ii) For residential real property held in the condominium form of 15 16 ownership with an assessed value of three hundred thousand dollars or 17 higher, a tax of at least ten percent and no more than thirteen and one-half percent of the excess assessed value above three hundred thou-18 19 sand dollars. 20 (iii) For dwelling units in a property held in the cooperative form of 21 ownership with an assessed value attributable to a tenant-stockholder of three hundred thousand dollars or higher, a tax of at least ten percent 22 and no more than thirteen and one-half percent of the excess assessed 23 value above three hundred thousand dollars. The additional taxes attrib-24 25 utable to each tenant-stockholder shall be added by the cooperative

apartment corporation to the amount of such taxes otherwise payable by
 or chargeable to such tenant-stockholder.
 (b) Subject to the limitations established in paragraph (a) of this

29 subdivision, any such local law may establish a graduated rate schedule 30 for imposing such tax, at rates and excess value thresholds as the local 31 legislative body determines appropriate.

32 (c) Except as otherwise provided in this section, such tax may be 33 imposed, administered, collected and enforced by the commissioner of 34 finance of such city by such means and in such manner as other taxes 35 that are now imposed, administered, collected and enforced by such 36 commissioner in accordance with the charter or administrative code of 37 any such city or as otherwise may be provided by any such local law.

38 4. Exemptions. (a) A local law enacted pursuant to this section shall include an exemption from the additional tax imposed for residential 39 properties or dwelling units that are: (i) the primary residence of at 40 41 least one owner of the property or dwelling unit; (ii) the primary resi-42 dence of a parent or child of at least one owner of the property or 43 dwelling unit; (iii) held in the condominium or cooperative form of ownership with an assessed value or assessed value attributable to a 44 45 tenant-stockholder of three hundred thousand dollars or higher, where 46 the owner has within the prior three years obtained an appraisal report 47 certified by a state certified real estate appraiser or authenticated by 48 a state licensed real estate appraiser, as those terms are defined in section one hundred sixty-a of the executive law, showing that the resi-49 dential property or dwelling unit has an appraised value of less than 50 51 five million dollars; or (iv) rented on a full-time basis to a tenant or tenants for whom the property or dwelling unit is their primary resi-52 53 dence.

54 (b) Proof that a residential property or dwelling unit is eligible for 55 an exemption provided in paragraph (a) of this subdivision shall be in A. 5736

3	(c) Any such local law may provide for exemptions from such tax in
4	addition to those specified in this subdivision.
5	(d) In the event that a property granted an exemption from taxation
б	pursuant to this section or local law ceases to be used in a manner
7	making the property eligible for such exemption, the owner or owners
8	shall so notify the commissioner of finance in a time, form and manner
9	as so required by local law or the rules of the commissioner.
10	5. Rules. The department of finance of any city enacting a local law
11	pursuant to this section shall have, in addition to any other functions,
12	powers and duties which have been or may be conferred on it by law, the
13	power to make and promulgate rules to carry out the purposes of this
14	section.

15 § 2. This act shall take effect immediately.
