Introduced by M. of A. DARLING -- read once and referred to the Committee on Local Governments

AN ACT in relation to authorizing the county of Nassau to transfer ownership of certain parkland to the village of Freeport

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Notwithstanding the provisions of any law to the contrary,
2 the Nassau county legislature is hereby authorized and empowered to
3 convey the property described in section two of this act, which was
4 heretofore used by such county for park and/or recreational purposes,
5 upon terms agreed upon between the parties, to the village of Freeport
6 for use by such village for park and/or recreational purposes, provided,
7 however, that such village of Freeport shall continue to provide access
8 to such parkland and/or recreational facilities to all residents of the
9 county of Nassau and the village shall not enact any fees or charges
10 which are higher for county residents who are not village residents. Any
11 revenues received from the county from the transfer shall be used for
12 capital improvements of existing park or recreational and/or the acquisition
13 of additional park or recreational facilities.

14 § 2. The lands referred to in section one of this act are located,
15 bounded and described as follows:

16 All that certain plot, piece or parcel of land with the buildings and
17 improvements thereon erected, situate, lying and being in the village of
18 Freeport, town of Hempstead, county of Nassau, State of New York, being
19 bounded and described as follows:

20 Beginning at a point, said point being the intersection of the southerly
21 line of West 5th Street and the westerly line of South Main Street;
22 running thence along the westerly line of South Main Street, South 01
23 degrees 29 minutes 00 seconds west 160.00 feet to a point of intersection
24 with the southerly line of South Main Street; running thence
25 along the westly line of South Main Street, South 88 degrees 31 minutes

20 of Supervisors on July 13, 1964 and "Map Showing Real Property to be
21 acquired for Public Structures and Facilities at the Southerly end of
22 South Main Street, Freeport, known as Cow Meadow Vicinity of Freeport,
23 Town of Hempstead" and dated October, 1963 and filed in the office of
24 the County Clerk on March 10, 1964 as case No. 7774 pursuant to Resol-
25 ution No. 230 adopted by the Nassau County Board of Supervisors on March
26 9, 1964.

27 § 3. The land to be transferred pursuant to this act and all struc-
28 tures and facilities situated on such land shall be maintained, owned
29 and operated for park purposes by the village of Freeport. The use of
30 such parkland and facilities shall continue to be made available to the
31 general public of the state of New York, including all residents of
32 Nassau county and the village of Freeport.

33 § 4. Where availability of such public parkland and facilities is
34 limited, the use of such parkland and facilities must be determined by
35 an equitable method which provides priority use to the general public of
36 the state of New York, including all residents of Nassau county and the
37 village of Freeport, based on a reservation policy for free or for a
38 nominal charge. Fees charged to non-residents of Nassau county or the
39 village of Freeport shall not exceed twice those charged to residents of
40 such county or village. Where there is no charge for residents of such
41 county or village but a fee is charged to non-residents, non-residents
42 fees cannot exceed fees charged for residents at comparable state or
43 local public facilities. Reservation, membership or annual permit
44 systems available to residents must also be available to non-residents
45 and the period of availability must be the same for both residents and
46 non-residents.

47 § 5. This act shall take effect immediately.
