AN ACT to extend the deadline for the filing of applications and renewal applications for real property tax abatement programs

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Notwithstanding any other provision of law, the deadline 2 for the filing of applications and renewal applications due to be filed in calendar year 2021 for any real property tax abatement program or real property tax exemption programs provided by any municipal corporation in this state shall be extended to July 15, 2021 provided the governing body of such municipal corporation adopts a local law, ordinance or resolution providing therefor. Any changes to tentative or final assessment rolls or tax rolls resulting from such an extension 9 will be treated as errors and corrected according to the procedures 10 established in sections 552, 553, and 554 of the real property tax law. § 2. The assessor of a participating municipal corporation shall mail 11 12 written notice of their denial of an exemption or abatement to the prop-13 erty owner and the participating municipal corporation. Where the asses-

sor denied the exemption or abatement, the property owner may file a complaint with the board of assessment review within a time frame determined by the local law, ordinance or resolution passed by the municipal corporation. Such board shall reconvene within 45 days of receiving a complaint and upon ten days written notice to the property owner and assessor to hear the appeal and determine the matter, and shall mail written notice of its determination to the assessor and property owner.
